### SCHEDULE 4

#### CONSTITUTION, POWERS AND PROCEEDINGS OF THE TRANSPORT TRIBUNAL

##### *Constitution*

- 1 The Transport Tribunal shall be a court of record and have an official seal which shall be judicially noticed.
- 2 (1) The tribunal shall consist of—
  - (a) a president and two or more chairmen appointed by the Lord Chancellor (referred to below in this Schedule as judicial members); and
  - (b) two or more other members appointed by the Secretary of State.
- [<sup>F1</sup>(2) The president of the tribunal shall be—
  - [<sup>F2</sup>(a) a person who satisfies the judicial-appointment eligibility condition on a 7-year basis; or]
  - (b) an advocate or solicitor in Scotland of at least [<sup>F3</sup>7] years' standing.
- (2A) Each chairman shall be—
  - [<sup>F4</sup>(a) a person who satisfies the judicial-appointment eligibility condition on a 5-year basis; or]
  - (b) an advocate or solicitor in Scotland of at least [<sup>F5</sup>5] years' standing.]
