1 Orders to which Part I applies. **U.K.**

(1) Subject to the following provisions of this section, in this Part “^[F1]custody order”^[F1] “^[F1]Part I order” means—

^[F2](a) an order made by a court in England and Wales under any of the following enactments—

- (i) ^[F3]section 9, 10] or 14A(2) of the ^{M1}Guardianship of Minors Act 1971 or ^[F3]section 2(4) or (5)(a)] of the ^{M2}Guardianship Act 1973;
- (ii) section 42(1) of the ^{M3}Matrimonial Causes Act 1973;
- (iii) section 42(2) of the Matrimonial Causes Act 1973;
- (iv) section 33(1) of the ^{M4}Children Act 1975 or ^[F4]section 2(4)(b)] of the Guardianship Act 1973 as applied by section 34(5) of the Children Act 1975;
- (v) section 8(2) or 19(1)(ii) of the ^{M5}Domestic Proceedings and Magistrates’ Courts Act 1978;]

^[F2](a) a section 8 order made by a court in England and Wales under the Children Act 1989, other than an order varying or discharging such an order]

(b) an order made by a court of civil jurisdiction in Scotland under any enactment or rule of law with respect to the custody, care or control of a child, access to a child or the education or upbringing of a child, excluding—

- (i) an order committing the care of a child to a local authority or placing a child under the supervision of a local authority;

 - [^{F7}(b) an order under section 14A(2) of the ^{M13}Guardianship of Minors Act 1971 which varies a previous custody order; or]

- (a) was made before the date of the commencement of this Part;
 - (b) in the case of an order within subsection (1)(b) or (d) above or an order under any of the enactments mentioned in subsection (4) below, is made on or after that date on an application made before that date; or
 - (c) in any other case, is made on or after that date in proceedings commenced before that date.
- (4) The said enactments are—
- (a) [F10sections 9] and 14A(2) of the Guardianship of Minors Act 1971 and section 33(1) of the M14Children Act 1975; and
 - (b) section 5 of the M15Guardianship of Infants Act 1886.
- (5) For the purposes of subsection (3) above an order made on two or more applications which are determined together shall be regarded as made on the first of those applications.]

CHAPTER II E+W

JURISDICTION OF COURTS IN ENGLAND AND WALES

[^{F11X1}2] **Jurisdiction in cases other than divorce, etc.** E+W

- (1) A court in England and Wales shall not have jurisdiction to make a custody order within section 1(1)(a) of this Act, other than one under section 42(1) of the ^{M16}Matrimonial Causes Act 1973, unless the condition in section 3 of this Act is satisfied.
- (2) The High Court in England and Wales shall have jurisdiction to make a custody order within section 1(1)(d) of this Act if, and only if,—
 - (a) the condition in section 3 of this Act is satisfied, or
 - (b) the ward is present in England and Wales on the relevant date (within the meaning of section 3(6) of this Act) and the court considers that the immediate exercise of its powers is necessary for his protection.]

- (1) A court in England and Wales shall not have jurisdiction to make a section 1(1)(a) order with respect to a child in or in connection with matrimonial proceedings in England and Wales unless the condition in section 2A of this Act is satisfied.
- (2) A court in England and Wales shall not have jurisdiction to make a section 1(1)(a) order in a non-matrimonial case (that is to say, where the condition in section 2A of this Act is not satisfied) unless the condition in section 3 of this Act is satisfied.
- (3) A court in England and Wales shall not have jurisdiction to make a section 1(1)(d) order unless—
 - (a) the condition in section 3 of this Act is satisfied, or
 - (b) the child concerned is present in England and Wales on the relevant date and the court considers that the immediate exercise of its powers is necessary for his protection.]

[^{F14F15} **2A Jurisdiction in or in connection with matrimonial proceedings.** **E+W**]

- (1) The condition referred to in section 2(1) of this Act is that the matrimonial proceedings are proceedings in respect of the marriage of the parents of the child concerned and—
 - (a) the proceedings—
 - (i) are proceedings for divorce or nullity of marriage, and
 - (ii) are continuing;
 - (b) the proceedings—
 - (i) are proceedings for judicial separation,
 - (ii) are continuing,and the jurisdiction of the court is not excluded by subsection (2) below; or
 - (c) the proceedings have been dismissed after the beginning of the trial but—
 - (i) the section 1(1)(a) order is being made forthwith, or
 - (ii) the application for the order was made on or before the dismissal.
- (2) For the purposes of subsection (1)(b) above, the jurisdiction of the court is excluded if, after the grant of a decree of judicial separation, on the relevant date, proceedings for divorce or nullity in respect of the marriage are continuing in Scotland or Northern Ireland.
- (3) Subsection (2) above shall not apply if the court in which the other proceedings there referred to are continuing has made—
 - (a) an order under section 13(6) or 21(5) of this Act (not being an order made by virtue of section 13(6)(a)(i)), or
 - (b) an order under section 14(2) or 22(2) of this Act which is recorded as being made for the purpose of enabling Part I proceedings to be taken in England and Wales with respect to the child concerned.

3 Habitual residence or presence of child. E+W

(1) The condition referred to in [F16section 2][F16section 2(2)] of this Act is that on the relevant date the child concerned—

- (a) is habitually resident in England and Wales, or
- (b) is present in England and Wales and is not habitually resident in any part of the United Kingdom,

and, in either case, the jurisdiction of the court is not excluded by subsection (2) below.

(2) For the purposes of subsection (1) above, the jurisdiction of the court is excluded if, on the relevant date, [F17proceedings for divorce, nullity or judicial separation][F17matrimonial proceedings] are continuing in a court in Scotland or Northern Ireland in respect of the marriage of the parents of the child concerned.

(3) Subsection (2) above shall not apply if the court in which the other proceedings there referred to are continuing has made—

- (a) an order under section 13(6) or 21(5) of this Act (not being an order made by virtue of section 13(6)(a)(i)), or
- (b) an order under section 14(2) or 22(2) of this Act which is recorded as made for the purpose of enabling [F18proceedings with respect to the custody of][F18Part I proceedings with respect to] the child concerned to be taken in England and Wales,

and that order is in force.

[F19(4) Subject to subsections (5) and (6) below, in this section “the relevant date” means the date of the commencement of the proceedings in which the custody order falls to be made.

[^{F21}4 Jurisdiction in divorce proceedings, etc. **E+W**

- (1) The enactments relating to the jurisdiction of courts in England and Wales to make orders under section 42(1) of the ^{M19}Matrimonial Causes Act 1973 shall have effect subject to the modifications provided for by this section.
- (2) In section 42(1)(b) of that Act (which enables orders as to custody and education to be made immediately, or within a reasonable period, after the dismissal of proceedings for divorce, etc.) for the words “within a reasonable period” there shall be substituted the words “(if an application for the order is made on or before the dismissal)”.
- (3) A court shall not have jurisdiction to make a custody order under section 42(1)(a) of that Act after the grant of a decree of judicial separation if, on the relevant date, proceedings for divorce or nullity in respect of the marriage concerned are continuing in Scotland or Northern Ireland.
- (4) Subsection (3) above shall not apply if the court in which the other proceedings there referred to are continuing has made—
 - (a) an order under section 13(6) or 21(5) of this Act (not being an order made by virtue of section 13(6)(a)(i)), or
 - (b) an order under section 14(2) or 22(2) of this Act which is recorded as made for the purpose of enabling proceedings with respect to the custody of the child concerned to be taken in England and Wales,and that order is in force.
- (5) Where a court—
 - (a) has jurisdiction to make a custody order under section 42(1) of the Matrimonial Causes Act 1973 in or in connection with proceedings for divorce, nullity of marriage or judicial separation, but
 - (b) considers that it would be more appropriate for matters relating to the custody of the child to be determined outside England and Wales,

5 Power of court to refuse application or stay proceedings. E+W

- (1) A court in England and Wales which has jurisdiction to make a [^{F22}custody order][^{F22}Part I order] may refuse an application for the order in any case where the matter in question has already been determined in proceedings outside England and Wales.
- (2) Where, at any stage of the proceedings on an application made to a court in England and Wales for a [^{F22}custody order][^{F22}Part I order], or for the variation of a [^{F22}custody order][^{F22}Part I order], it appears to the court—
 - (a) that proceedings with respect to the matters to which the application relates are continuing outside England and Wales, or
 - (b) that it would be more appropriate for those matters to be determined in proceedings to be taken outside England and Wales,
 the court may stay the proceedings on the application.
- (3) The court may remove a stay granted in accordance with subsection (2) above if it appears to the court that there has been unreasonable delay in the taking or prosecution of the other proceedings referred to in that subsection, or that those proceedings are stayed, sisted or concluded.
- (4) Nothing in this section shall affect any power exercisable apart from this section to refuse an application or to grant or remove a stay.

6 Duration and variation of custody orders. E+W

- (1) If a [^{F23}custody order][^{F23}Part I order] made by a court in Scotland or Northern Ireland (or a variation of such an order) comes into force with respect to a child at a time

- (b) those proceedings are continuing; and
- (c) the decree of judicial separation has not yet been granted.]

(4) Subsection (3) above shall not apply if the court in which the proceedings there referred to are continuing has made—

- (a) an order under section 13(6) or 21(5) of this Act (not being an order made by virtue of section 13(6)(a)(i)), or
- (b) an order under section 14(2) or 22(2) of this Act which is recorded as made for the purpose of enabling [^{F25}proceedings with respect to the custody of][^{F25}Part I proceedings with respect to] the child concerned to be taken in England and Wales,

and that order is in force.

20 Habitual residence or presence of child. **N.I.**

21 Jurisdiction in divorce proceedings, etc. **N.I.**

22 Power of court to refuse application or stay proceedings. **N.I.**

- (1) A court in Northern Ireland which has jurisdiction to make a [^{F56}custody order][^{F56}Part I order] may refuse an application for the order in any case where the matter in question has already been determined in proceedings outside Northern Ireland.

23 Duration and variation of custody orders. **N.I.**

CHAPTER V **U.K.**

RECOGNITION AND ENFORCEMENT

25 Recognition of custody orders: general. **U.K.**

- (1) Where a [^{F61}custody order][^{F61}Part I order] made by a court in any part of the United Kingdom is in force with respect to a child who has not attained the age of sixteen, then, subject to subsection (2) below, the order shall be recognised in any other part of the United Kingdom as having the same effect in that other part as if it had been made by the appropriate court in that other part and as if that court had had jurisdiction to make it.

35 Powers to restrict removal of child from jurisdiction. **U.K.**

- [^{F68}(1) In each of the following enactments (which enable courts to restrict the removal of a child from England and Wales)—

36 Effect of orders restricting removal. **U.K.**

- (1) This section applies to any order made by a court in the United Kingdom prohibiting the removal of a child from the United Kingdom or from any specified part of it.
- (2) An order to which this section applies shall have effect in each part of the United Kingdom other than the part in which it was made—
- (a) as if it had been made by the appropriate court in that other part, and
 - (b) in the case of an order which has the effect of prohibiting the child’s removal to that other part, as if it had included a prohibition on his further removal to any place except one to which he could be removed consistently with the order.

Parties to proceedings for or relating to a ^{F70}custody order][^{F70}Part I order] shall, to such extent and in such manner as may be prescribed, give particulars of other proceedings known to them which relate to the child concerned (including proceedings instituted abroad and proceedings which are no longer continuing).

41 Habitual residence after removal without consent, etc. **U.K.**

- (1) Where a child who—
- (a) has not attained the age of sixteen, and
 - (b) is habitually resident in a part of the United Kingdom,
- becomes habitually resident outside that part of the United Kingdom in consequence of circumstances of the kind specified in subsection (2) below, he shall be treated for the purposes of this Part as continuing to be habitually resident in that part of the United Kingdom for the period of one year beginning with the date on which those circumstances arise.

43 Application of Part I to dependent territories. **U.K.**

- (1) Her Majesty may by Order in Council make provision corresponding to or applying any of the foregoing provisions of this Part, with such modifications as appear to Her Majesty to be appropriate, for the purpose of regulating—
- in any dependent territory;
 - as between any dependent territory and any part of the United Kingdom; or
 - as between any dependent territory and any other such territory,
- the jurisdiction of courts to make custody orders, or orders corresponding to custody orders, and the recognition and enforcement of such orders.
- (2) In subsection (1) above “dependent territory” means any of the following territories—
- the Isle of Man,
 - any of the Channel Islands, and
 - any colony.
- (3) An Order in Council under subsection (1) above may contain such consequential, incidental and supplementary provisions as appear to Her Majesty to be necessary or expedient.
