[41B] ^{F1} **Provision of information as to exemption from council tax**

A billing authority within the meaning of Part I of the Local Government Finance Act 1992 shall, if so requested in writing by a rent officer or [^{F2}the appropriate tribunal] in connection with his or their functions under any enactment, inform the rent officer or [^{F2}the appropriate tribunal] in writing whether or not a particular dwelling (within the meaning of Part I of the Local Government Finance Act 1992) is, or was at any time specified in the request, an exempt dwelling for the purposes of that Part of that Act.]
