



# Child Support Act 1991

## 1991 CHAPTER 48

### E+W+S

An Act to make provision for the [<sup>F1</sup>calculation], collection and enforcement of periodical maintenance payable by certain parents with respect to children of theirs who are not in their care; for the collection and enforcement of certain other kinds of maintenance; and for connected purposes. [25th July 1991]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

### *The basic principles*

## 1 The duty to maintain. **E+W+S**

- (1) For the purposes of this Act, each parent of a qualifying child is responsible for maintaining him.
- (2) For the purposes of this Act, [<sup>F2</sup>a non-resident parent] shall be taken to have met his responsibility to maintain any qualifying child of his by making periodical payments of maintenance with respect to the child of such amount, and at such intervals, as may be determined in accordance with the provisions of this Act.
- (3) Where a [<sup>F3</sup>maintenance calculation] made under this Act requires the making of periodical payments, it shall be the duty of the [<sup>F2</sup>non-resident parent] with respect to whom the [<sup>F1</sup>calculation] was made to make those payments.

## 2 Welfare of children: the general principle. **E+W+S**

Where, in any case which falls to be dealt with under this Act, the [<sup>F4</sup>Secretary of State]<sup>F5</sup>... is considering the exercise of any discretionary power conferred by this Act, [<sup>F6</sup>the Secretary of State] shall have regard to the welfare of any child likely to be affected by [<sup>F7</sup>the] decision.

### 3 Meaning of certain terms used in this Act. **E+W+S**

- (1) A child is a “qualifying child” if—
- one of his parents is, in relation to him, [<sup>F2</sup>a non-resident parent]; or
  - both of his parents are, in relation to him, [<sup>F2</sup>non-resident parents].
- (2) The parent of any child is [<sup>F2</sup>a “non-resident parent”], in relation to him, if—
- that parent is not living in the same household with the child; and
  - the child has his home with a person who is, in relation to him, a person with care.
- (3) A person is a “person with care”, in relation to any child, if he is a person—
- with whom the child has his home;
  - who usually provides day to day care for the child (whether exclusively or in conjunction with any other person); and
  - who does not fall within a prescribed category of person.
- (4) The Secretary of State shall not, under subsection (3)(c), prescribe as a category—
- parents;
  - guardians;
  - persons in whose favour residence orders under section 8 of the <sup>M1</sup>Children Act 1989 are in force;
  - in Scotland, persons [<sup>F8</sup>with whom a child is to live by virtue of a residence order under section 11 of the Children (Scotland) Act 1995.]
- (5) For the purposes of this Act there may be more than one person with care in relation to the same qualifying child.
- (6) Periodical payments which are required to be paid in accordance with a [<sup>F3</sup>maintenance calculation] are referred to in this Act as “child support maintenance”.
- (7) Expressions are defined in this section only for the purposes of this Act.

## 4 Child support maintenance. **E+W+S**

- (1) A person who is, in relation to any qualifying child or any qualifying children, either the person with care or the [<sup>F2</sup>non-resident parent] may apply to the [<sup>F9</sup>Secretary of State] for a [<sup>F3</sup>maintenance calculation] to be made under this Act with respect to that child, or any of those children.
- (2) Where a [<sup>F3</sup>maintenance calculation] has been made in response to an application under this section the [<sup>F10</sup>Secretary of State] may, if the person with care or [<sup>F2</sup>non-resident parent] with respect to whom the [<sup>F1</sup>calculation] was made applies to [<sup>F10</sup>the Secretary of State] under this subsection, arrange for—
  - (a) the collection of the child support maintenance payable in accordance with the [<sup>F1</sup>calculation];
  - (b) the enforcement of the obligation to pay child support maintenance in accordance with the [<sup>F1</sup>calculation].
- (3) Where an application under subsection (2) for the enforcement of the obligation mentioned in subsection (2)(b) authorises the [<sup>F11</sup>Secretary of State] to take steps to enforce that obligation whenever [<sup>F11</sup>the Secretary of State] considers it necessary to do so, the [<sup>F11</sup>Secretary of State] may act accordingly.
- (4) A person who applies to the [<sup>F12</sup>Secretary of State] under this section shall, so far as that person reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the [<sup>F12</sup>Secretary of State]<sup>F13</sup>... being provided with the information which is required to enable—

- (5) Any person who has applied to the [F15Secretary of State] under this section may at any time request [F15the Secretary of State] to cease acting under this section.
- (6) It shall be the duty of the [F16Secretary of State] to comply with any request made under subsection (5) (but subject to any regulations made under subsection (8)).
- (7) The obligation to provide information which is imposed by subsection (4)—
- (a) shall not apply in such circumstances as may be prescribed; and
  - (b) may, in such circumstances as may be prescribed, be waived by the [F17Secretary of State].
- (8) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.

### 5 Child support maintenance: supplemental provisions. **E+W+S**

- (1) Where—
- (a) there is more than one person with care of a qualifying child; and
  - (b) one or more, but not all, of them have parental responsibility for <sup>F25</sup>... the child; no application may be made for a [<sup>F3</sup>maintenance calculation] with respect to the child by any of those persons who do not have parental responsibility for <sup>F25</sup>... the child.
- (2) Where more than one application for a [<sup>F3</sup>maintenance calculation] is made with respect to the child concerned, only one of them may be proceeded with.
- (3) The Secretary of State may by regulations make provision as to which of two or more applications for a [<sup>F3</sup>maintenance calculation] with respect to the same child is to be proceeded with.

- (2) An application made under subsection (1) shall authorise the <sup>F27</sup>Secretary of State] to make a <sup>F3</sup>maintenance calculation] with respect to any other children of the <sup>F2</sup>non-resident parent] who are qualifying children in the care of the same person as the child making the application.

- (4) Where an application under subsection (3) for the enforcement of the obligation mentioned in subsection (3)(b) authorises the <sup>F30</sup>Secretary of State] to take steps to enforce that obligation whenever <sup>F30</sup>the Secretary of State] considers it necessary to do so, the <sup>F30</sup>Secretary of State] may act accordingly.
- (5) Where a child has asked the <sup>F31</sup>Secretary of State] to proceed under this section, the person with care of the child, the <sup>F2</sup>non-resident parent] and the child concerned shall, so far as they reasonably can, comply with such regulations as may be made by the Secretary of State with a view to the <sup>F31</sup>Secretary of State] <sup>F32</sup>... being provided with the information which is required to enable—
- (a) the <sup>F2</sup>non-resident parent] to be traced (where that is necessary);
- (b) the amount of child support maintenance payable by the <sup>F2</sup>non-resident parent] to be assessed; and
- (c) that amount to be recovered from the <sup>F2</sup>non-resident parent].
- (6) The child who has made the application (but not the person having care of him) may at any time request the <sup>F33</sup>Secretary of State] to cease acting under this section.
- (7) It shall be the duty of the <sup>F33</sup>Secretary of State] to comply with any request made under subsection (6) (but subject to any regulations made under subsection (9)).
- (8) The obligation to provide information which is imposed by subsection (5)—
- (a) shall not apply in such circumstances as may be prescribed by the Secretary of State; and
- (b) may, in such circumstances as may be so prescribed, be waived by the <sup>F34</sup>Secretary of State].
- (9) The Secretary of State may by regulations make such incidental, supplemental or transitional provision as he thinks appropriate with respect to cases in which he is requested to cease to act under this section.
- <sup>F35</sup>(10) No application may be made at any time under this section by a qualifying child if
- <sup>F36</sup>(a) [ there is in force a written maintenance agreement made before 5th April 1993, or a maintenance order <sup>F37</sup>made before a prescribed date], in respect of that child and the person who is, at that time, the <sup>F2</sup>non-resident parent]<sup>F38</sup> or

## 8 Role of the courts with respect to maintenance for children. **E+W+S**

- (1) This subsection applies in any case where [<sup>F40</sup>the [<sup>F41</sup>Secretary of State]] would have jurisdiction to make a [<sup>F3</sup>maintenance calculation] with respect to a qualifying child and [<sup>F2</sup>a non-resident parent] of his on an application duly made <sup>F42</sup>... by a person entitled to apply for such [<sup>F1</sup>a calculation] with respect to that child.
  - (2) Subsection (1) applies even though the circumstances of the case are such that [<sup>F40</sup>the [<sup>F41</sup>Secretary of State]] would not make [<sup>F1</sup>a calculation] if it were applied for.
  - (3) [<sup>F43</sup>Except as provided in subsection (3A),] in any case where subsection (1) applies, no court shall exercise any power which it would otherwise have to make, vary or revive any maintenance order in relation to the child and [<sup>F2</sup>non-resident parent] concerned.
- [<sup>F44</sup>(3A) Unless a maintenance calculation has been made with respect to the child concerned, subsection (3) does not prevent a court from varying a maintenance order in relation to that child and the non-resident parent concerned—

  - (b) where the order was made before then, in any case in which section 4(10) or 7(10) prevents the making of an application for a maintenance calculation with respect to or by that child.]

- (6) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if—
- (a) a [<sup>F3</sup>maintenance calculation] is in force with respect to the child;
  - [<sup>F46</sup>(b) the non-resident parent's net weekly income exceeds the figure referred to in paragraph 10(3) of Schedule 1 (as it has effect from time to time pursuant to regulations made under paragraph 10A(1)(b)); and]
  - (c) the court is satisfied that the circumstances of the case make it appropriate for the [<sup>F2</sup>non-resident parent] to make or secure the making of periodical payments under a maintenance order in addition to the child support maintenance payable by him in accordance with the [<sup>F3</sup>maintenance calculation].
- (7) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if—
- (a) the child is, will be or (if the order were to be made) would be receiving instruction at an educational establishment or undergoing training for a trade, profession or vocation (whether or not while in gainful employment); and
  - (b) the order is made solely for the purposes of requiring the person making or securing the making of periodical payments fixed by the order to meet some or all of the expenses incurred in connection with the provision of the instruction or training.
- (8) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if—
- (a) a disability living allowance is paid to or in respect of him; or
  - (b) no such allowance is paid but he is disabled,
- and the order is made solely for the purpose of requiring the person making or securing the making of periodical payments fixed by the order to meet some or all of any expenses attributable to the child's disability.
- (9) For the purposes of subsection (8), a child is disabled if he is blind, deaf or dumb or is substantially and permanently handicapped by illness, injury, mental disorder or congenital deformity or such other disability as may be prescribed.
- (10) This section shall not prevent a court from exercising any power which it has to make a maintenance order in relation to a child if the order is made against a person with care of the child.
- (11) In this Act “maintenance order”, in relation to any child, means an order which requires the making or securing of periodical payments to or for the benefit of the child and which is made under—
- (a) Part II of the <sup>M2</sup>Matrimonial Causes Act 1973;
  - (b) the <sup>M3</sup>Domestic Proceedings and Magistrates' Courts Act 1978;

## 9 Agreements about maintenance. **E+W+S**

- (1) In this section “maintenance agreement” means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
  - (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.
  - (3) [<sup>F50</sup>Subject to section 4(10)(a) [<sup>F51</sup>and (ab)] and section 7(10),] the existence of a maintenance agreement shall not prevent any party to the agreement, or any other person, from applying for a [<sup>F3</sup>maintenance calculation] with respect to any child to or for whose benefit periodical payments are to be made or secured under the agreement.
  - (4) Where any agreement contains a provision which purports to restrict the right of any person to apply for a [<sup>F3</sup>maintenance calculation], that provision shall be void.
  - (5) Where section 8 would prevent any court from making a maintenance order in relation to a child and [<sup>F2</sup>a non-resident parent] of his, no court shall exercise any power that it has to vary any agreement so as—
    - (a) to insert a provision requiring that [<sup>F2</sup>non-resident parent] to make or secure the making of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of that child; or
    - (b) to increase the amount payable under such a provision.

**10 Relationship between maintenance [<sup>F1</sup>calculations] and certain court orders and related matters. **E+W+S****

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [<sup>F3</sup>maintenance calculation] is made, the order—
- (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
  - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [<sup>F3</sup>maintenance calculation] is made, the agreement—

## 15 Powers of inspectors. **E+W+S**

- (2) Where a [<sup>F3</sup>maintenance calculation] is made under this Act, payments of child support maintenance under the [<sup>F1</sup>calculation] shall be made in accordance with regulations made by the Secretary of State.

### 31 Deduction from earnings orders. **E+W+S**

- (1) This section applies where any person (“the liable person”) is liable to make payments of child support maintenance.
- (2) The [<sup>F302</sup>Secretary of State] may make an order (“a deduction from earnings order”) against a liable person to secure the payment of any amount due under the [<sup>F3</sup>maintenance calculation] in question.
- (3) A deduction from earnings order may be made so as to secure the payment of—
  - (a) arrears of child support maintenance payable under the [<sup>F1</sup>calculation];
  - (b) amounts of child support maintenance which will become due under the [<sup>F1</sup>calculation]; or
  - (c) both such arrears and such future amounts.
- (4) A deduction from earnings order—
  - (a) shall be expressed to be directed at a person (“the employer”) who has the liable person in his employment; and
  - (b) shall have effect from such date as may be specified in the order.
- (5) A deduction from earnings order shall operate as an instruction to the employer to—
  - (a) make deductions from the liable person’s earnings; and
  - (b) pay the amounts deducted to the [<sup>F303</sup>Secretary of State].
- (6) The [<sup>F304</sup>Secretary of State] shall serve a copy of any deduction from earnings order [<sup>F304</sup>made] under this section on—

## 32 Regulations about deduction from earnings orders. **E+W+S**

- (1) The Secretary of State may by regulations make provision with respect to deduction from earnings orders.
- (2) The regulations may, in particular, make provision—
- (a) as to the circumstances in which one person is to be treated as employed by another;
  - (b) requiring any deduction from earnings under an order to be made in the prescribed manner;
  - <sup>F305</sup>(bb) for the amount or amounts which are to be deducted from the liable person's earnings not to exceed a prescribed proportion of his earnings (as determined by the employer);]
  - (c) requiring an order to specify the amount or amounts to which the order relates and the amount or amounts which are to be deducted from the liable person's earnings in order to meet his liabilities under the [<sup>F3</sup> maintenance calculation] in question;
  - (d) requiring the intervals between deductions to be made under an order to be specified in the order;
  - (e) as to the payment of sums deducted under an order to the [<sup>F306</sup> Secretary of State];
  - (f) allowing the person who deducts and pays any amount under an order to deduct from the liable person's earnings a prescribed sum towards his administrative costs;
  - (g) with respect to the notification to be given to the liable person of amounts deducted, and amounts paid, under the order;
  - (h) requiring any person on whom a copy of an order is served to notify the [<sup>F306</sup> Secretary of State] in the prescribed manner and within a prescribed period if he does not have the liable person in his employment or if the liable person ceases to be in his employment;

  - (b) any person who becomes the liable person's employer and knows that the order is in force shall notify the [<sup>F306</sup>Secretary of State], in the prescribed manner and within a prescribed period, that he is the liable person's employer, and shall include in such a notification a statement of the liable person's earnings and expected earnings from the employment concerned and of such other matters as may be prescribed.
- (4) The regulations may include provision with respect to the priority as between a deduction from earnings order and—
- (a) any other deduction from earnings order;
  - (b) any order under any other enactment relating to England and Wales which provides for deductions from the liable person's earnings;
  - (c) any diligence against earnings.
- (5) The regulations may include a provision that a liable person may appeal to a magistrates' court (or in Scotland to the sheriff) if he is aggrieved by the making of a deduction from earnings order against him, or by the terms of any such order, or there is a dispute as to whether payments constitute earnings or as to any other prescribed matter relating to the order.
- (6) On an appeal under subsection (5) the court or (as the case may be) the sheriff shall not question the [<sup>F3</sup>maintenance calculation] by reference to which the deduction from earnings order was made.
- (7) Regulations made by virtue of subsection (5) may include [<sup>F307</sup>—
- (a) provision with respect to the period within which a right of appeal under the regulations may be exercised;
  - (b) provision as to the powers of a magistrates' court, or in Scotland of the sheriff, in relation to an appeal (which may include provision as to the quashing of a deduction from earnings order or the variation of the terms of such an order).

### [<sup>F308</sup>32A Orders for regular deductions from accounts **E+W+S**

- (1) If in relation to any person it appears to the [<sup>F309</sup>Secretary of State]—
- that the person has failed to pay an amount of child support maintenance; and

### 32F Lump sum deductions: final orders **E+W+S**

  - (b) if the order is made in respect of a joint account, shall not exceed the amount that appears to the Commission to be fair in all the circumstances.
- (4) In determining the amount to be specified in an order made in respect of a joint account the [<sup>F322</sup>Secretary of State] shall have particular regard—
  - (a) to the amount contributed to the account by each of the account-holders; and
  - (b) to such other matters as may be prescribed.
- (5) An order under this section may specify an amount of arrears due under a maintenance calculation which is the subject of an appeal only if it appears to the [<sup>F322</sup>Secretary of State]—
  - (a) that liability for the amount would not be affected were the appeal to succeed; or
  - (b) where paragraph (a) does not apply, that the making of an order under this section in respect of the amount would nonetheless be fair in all the circumstances.

### 32G Orders under sections 32E and 32F: freezing of accounts etc. **E+W+S**

- (1) During the relevant period, an order under section 32E or 32F which specifies an account held with a deposit-taker shall operate as an instruction to the deposit-taker not to do anything that would reduce the amount standing to the credit of the account below the amount specified in the order (or, if already below that amount, that would further reduce it).

### 32H Orders under section 32F: deductions and payments **E+W+S**

### 32J Regulations about orders under section 32E or 32F **E+W+S**

- (1) The Secretary of State may by regulations make provision with respect to orders under section 32E or 32F.

### 32K Lump sum deduction orders: offences **E+W+S**

### [<sup>F327</sup>32L Orders preventing avoidance **E+W+S**

- (1) The [<sup>F328</sup>Secretary of State] may apply to the court, on the grounds that a person—
  - (a) has failed to pay an amount of child support maintenance, and
  - (b) with the intention of avoiding payment of child support maintenance, is about to make a disposition or to transfer out of the jurisdiction or otherwise deal with any property,

### 33 Liability orders. **E+W+S**

- (1) This section applies where—
- (a) a person who is liable to make payments of child support maintenance (“the liable person”) fails to make one or more of those payments; and
  - (b) it appears to the [<sup>F330</sup>Secretary of State] that—
    - (i) it is inappropriate to make a deduction from earnings order against him (because, for example, he is not employed); or
    - (ii) although such an order has been made against him, it has proved ineffective as a means of securing that payments are made in accordance with the [<sup>F3</sup>maintenance calculation] in question.

### 34 Regulations about liability orders. **E+W+S**

### 35 Enforcement of liability orders by distress. **E+W**

- (1) Where a liability order has been made against a person (“the liable person”), the [<sup>F339</sup>Secretary of State] may levy the appropriate amount by distress and sale of the liable person’s goods.
- (2) In subsection (1), “the appropriate amount” means the aggregate of—
- the amount in respect of which the order was made, to the extent that it remains unpaid; and
  - an amount, determined in such manner as may be prescribed, in respect of the charges connected with the distress.

  - (a) he is under the age of 16;
  - (b) he is under the age of 19 and receiving full-time education (which is not advanced education)—
    - (i) by attendance at a recognised educational establishment; or
    - (ii) elsewhere, if the education is recognised by the Secretary of State; or
  - (c) he does not fall within paragraph (a) or (b) but—
    - (i) he is under the age of 18, and
    - (ii) prescribed conditions are satisfied with respect to him.
- (2) A person is not a child for the purposes of this Act if he—
  - (a) is or has been married [<sup>F457</sup>or a civil partner];
  - (b) has celebrated a marriage [<sup>F458</sup>, or been a party to a civil partnership,] which is void; or
  - (c) has celebrated a marriage in respect of which a decree of nullity has been granted [<sup>F459</sup>or has been a party to a civil partnership in respect of which a nullity order has been made].
- (3) In this section—

“advanced education” means education of a prescribed description; and

“recognised educational establishment” means an establishment recognised by the Secretary of State for the purposes of this section as being, or as comparable to, a university, college or school.
- (4) Where a person has reached the age of 16, the Secretary of State may recognise education provided for him otherwise than at a recognised educational establishment only if the Secretary of State is satisfied that education was being so provided for him immediately before he reached the age of 16.
- (5) The Secretary of State may provide that in prescribed circumstances education is or is not to be treated for the purposes of this section as being full-time.
- (6) In determining whether a person falls within subsection (1)(b), no account shall be taken of such interruptions in his education as may be prescribed.
- (7) The Secretary of State may by regulations provide that a person who ceases to fall within subsection (1) shall be treated as continuing to fall within that subsection for a prescribed period.

  - (a) the enforcement of a [F<sup>3</sup> maintenance calculation] (including the collection of sums payable under the [F<sup>1</sup> calculation]) as if the [F<sup>1</sup> calculation] were a court order of a prescribed kind;
  - (b) the registration of maintenance [F<sup>1</sup> calculations] with the appropriate court in connection with any provision of a kind mentioned in paragraph (a);
  - (c) the variation, on application made to a court, of the provisions of a [F<sup>3</sup> maintenance calculation] relating to the method of making payments fixed by the [F<sup>1</sup> calculation] or the intervals at which such payments are to be made;
  - (d) a [F<sup>3</sup> maintenance calculation], or an order of a prescribed kind relating to one or more children, to be deemed, in prescribed circumstances, to have been validly made for all purposes or for such purposes as may be prescribed.

#### *General rule*

- 1 (1) The weekly rate of child support maintenance is the basic rate unless a reduced rate, a flat rate or the nil rate applies.
- (2) Unless the nil rate applies, the amount payable weekly to a person with care is—
- (a) the applicable rate, if paragraph 6 does not apply; or
  - (b) if paragraph 6 does apply, that rate as apportioned between the persons with care in accordance with paragraph 6,
- as adjusted, in either case, by applying the rules about shared care in paragraph 7 or 8.

#### *Basic rate*

- 2 (1) The basic rate is the following percentage of the non-resident parent's net weekly income—
- 15% where he has one qualifying child;
  - 20% where he has two qualifying children;
  - 25% where he has three or more qualifying children.
- (2) If the non-resident parent also has one or more relevant other children, the appropriate percentage referred to in sub-paragraph (1) is to be applied instead to his net weekly income less—

*Reduced rate*

- 3 (1) A reduced rate is payable if—
- (a) neither a flat rate nor the nil rate applies; and
  - (b) the non-resident parent's net weekly income is less than £200 but more than £100.
- (2) The reduced rate payable shall be prescribed in, or determined in accordance with, regulations.
- (3) The regulations may not prescribe, or result in, a rate of less than £5.

*Flat rate*

- 4 (1) Except in a case falling within sub-paragraph (2), a flat rate of £5 is payable if the nil rate does not apply and—
- (a) the non-resident parent's net weekly income is £100 or less; or
  - (b) he receives any benefit, pension or allowance prescribed for the purposes of this paragraph of this sub-paragraph; or
  - (c) he or his partner (if any) receives any benefit prescribed for the purposes of this paragraph of this sub-paragraph.
- (2) A flat rate of a prescribed amount is payable if the nil rate does not apply and—
- (a) the non-resident parent has a partner who is also a non-resident parent;
  - (b) the partner is a person with respect to whom a maintenance calculation is in force; and
  - (c) the non-resident parent or his partner receives any benefit prescribed under sub-paragraph (1)(c).
- (3) The benefits, pensions and allowances which may be prescribed for the purposes of sub-paragraph (1)(b) include ones paid to the non-resident parent under the law of a place outside the United Kingdom.

*Nil rate*

- 5 The rate payable is nil if the non-resident parent—
- (a) is of a prescribed description; or
  - (b) has a net weekly income of below £5.

*Apportionment*

- 6 (1) If the non-resident parent has more than one qualifying child and in relation to them there is more than one person with care, the amount of child support maintenance payable is (subject to paragraph 7 or 8) to be determined by apportioning the rate between the persons with care.

- (4) The amount of that decrease for one child is set out in the following Table—

Number of nights	Fraction to subtract
52 to 103	One-seventh

- (5) If the person with care is caring for more than one qualifying child of the non-resident parent, the applicable decrease is the sum of the appropriate fractions in the Table divided by the number of such qualifying children.
- (6) If the applicable fraction is one-half in relation to any qualifying child in the care of the person with care, the total amount payable to the person with care is then to be further decreased by £7 for each such child.
- (7) If the application of the preceding provisions of this paragraph would decrease the weekly amount of child support maintenance (or the aggregate of all such amounts) payable by the non-resident parent to the person with care (or all of them) to less than £5, he is instead liable to pay child support maintenance at the rate of £5 a week, apportioned (if appropriate) in accordance with paragraph 6.
