9 Agreements about maintenance. E+W+S

- (1) In this section "maintenance agreement" means any agreement for the making, or for securing the making, of periodical payments by way of maintenance, or in Scotland aliment, to or for the benefit of any child.
- (2) Nothing in this Act shall be taken to prevent any person from entering into a maintenance agreement.

Relationship between maintenance [F1 calculations] and certain court orders and related matters. E+W+S

- (1) Where an order of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [F3 maintenance calculation] is made, the order—
 - (a) shall, so far as it relates to the making or securing of periodical payments, cease to have effect to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (2) Where an agreement of a kind prescribed for the purposes of this subsection is in force with respect to any qualifying child with respect to whom a [F3 maintenance calculation] is made, the agreement—
 - (a) shall, so far as it relates to the making or securing of periodical payments, be unenforceable to such extent as may be determined in accordance with regulations made by the Secretary of State; or
 - (b) where the regulations so provide, shall, so far as it so relates, have effect subject to such modifications as may be so determined.
- (3) Any regulations under this section may, in particular, make such provision with respect to—
 - (a) any case where any person with respect to whom an order or agreement of a kind prescribed for the purposes of subsection (1) or (2) has effect applies to the prescribed court, before the end of the prescribed period, for the order or agreement to be varied in the light of the [F3 maintenance calculation] and of the provisions of this Act;
 - (b) the recovery of any arrears under the order or agreement which fell due before the coming into force of the [F3maintenance calculation],

as the Secretary of State considers appropriate and may provide that, in prescribed circumstances, an application to any court which is made with respect to an order of a prescribed kind relating to the making or securing of periodical payments to or for the benefit of a child shall be treated by the court as an application for the order to be revoked.

- (4) The Secretary of State may by regulations make provision for
 - notification to be given by [F60] the [F61] Secretary of State] to the prescribed person in any case where [F61] the Secretary of State] considers that the making of a [F3] maintenance calculation] has affected, or is likely to affect, any order of a kind prescribed for the purposes of this subsection;
 - (b) notification to be given by the prescribed person to the [F62Secretary of State] in any case where a court makes an order which it considers has affected, or is likely to affect, a [F3maintenance calculation].

31 Deduction from earnings orders. E+W+S

 - (c) so to provide for a person to exercise a discretion in dealing with any matter.

57 Application to Crown. E+W+S

- (1) The power of the Secretary of State to make regulations under section 14 requiring prescribed persons to furnish information may be exercised so as to require information to be furnished by persons employed in the service of the Crown or otherwise in the discharge of Crown functions.

 - (c) the variation, on application made to a court, of the provisions of a [F3maintenance calculation] relating to the method of making payments fixed by the [F1calculation] or the intervals at which such payments are to be made;
 - (d) a [F3 maintenance calculation], or an order of a prescribed kind relating to one or more children, to be deemed, in prescribed circumstances, to have been validly made for all purposes or for such purposes as may be prescribed.
