[128E ^{F1}Information about attainment of standards.

- (1) Where directions have been given to the Housing Executive under [^{F2}section 128D(3A) or (3B)] above, the Department may require the Executive to supply to it any information which the Department considers may assist it in deciding—
 - (a) whether the Executive has attained the standards which it has been directed to attain; or
 - [whether the Housing Executive has taken the action which it has been directed ^{F3}(aa) to take;]
 - (b) whether the Executive is likely to attain those standards [^{F4}or take that action] within the time specified in the directions.
- (2) Information shall be supplied under subsection (1) above in such manner and form as the Department may require.]
