### PART IV

#### AIR QUALITY

#### 81 Functions of the new Agencies.

- (1) In discharging its pollution control functions, each new Agency [<sup>F1</sup>and the Natural Resources Body for Wales] shall have regard to the strategy.
- (2) In this section “pollution control functions” <sup>F2</sup>... [<sup>F3</sup>means]—
  - (a) [<sup>F4</sup>means] in the case of the Agency [<sup>F5</sup>or the Natural Resources Body for Wales], the functions conferred on it by or under the enactments specified in section 5(5) above [<sup>F6</sup>(subject, in the case of the Body, to section 5(6) above)] ; or
  - (b) in the case of SEPA, [<sup>F7</sup>the functions conferred on it by or under the enactments specified in section 33(5) above][<sup>F7</sup>has the same meaning as in section 108(15) below in relation to SEPA].
