APPEALS FROM SUMMARY PROCEEDINGS

Disposal of appeals

190 Disposal of appeal where appellant [^{F1}not criminally responsible].

- (1) In relation to any appeal under section 175(2) of this Act, the [^{F2}Sheriff Appeal Court] shall, where it appears to it that the appellant committed the act charged against him but that he was [^{F3}not, because of section 51A of this Act, criminally responsible for it], dispose of the appeal by—
 - (a) setting aside the verdict of the inferior court and substituting therefor a verdict of acquittal $[^{F4}$ by reason of the special defence set out in section 51A of this Act]; and
 - (b) quashing any sentence imposed on the appellant as respects the complaint and—
 - (i) making, in respect of the appellant, any order mentioned in section 57(2)(a) to (d) of this Act; or
 - (ii) making no order.
- (2) [^{F5}Subsections (3) to (6)] of section 57 of this Act shall apply to an order made under subsection (1)(b)(i) above as it applies to an order made under subsection (2) of that section.
