An Act to make provision for the National Criminal Intelligence Service and the National Crime Squad; to make provision about entry on and interference with property and with wireless telegraphy in the course of the prevention or detection of serious crime; to make provision for the Police Information Technology Organisation; to provide for the issue of certificates about criminal records; to make provision about the administration and organisation of the police; to repeal certain enactments about rehabilitation of offenders; and for connected purposes. The Service Authority

1 **The Service Authority for the National Criminal Intelligence Service.** U.K.

- (1) There shall be a body corporate to be known as the Service Authority for the National Criminal Intelligence Service (in this Part referred to as “the NCIS Service Authority”).
- (2) Subject to the following provisions of this section, the NCIS Service Authority shall consist of [^{F1}eleven] members.
- (3) The Secretary of State may by order provide that the number of members shall be a specified odd number greater than [^{F1}eleven].
- (4) Before making an order under subsection (3), the Secretary of State shall consult—
 - (a) the NCIS Service Authority ^{F2}. . . ,

Functions

2 General functions of the NCIS Service Authority and NCIS. **U.K.**

- (1) The NCIS Service Authority shall maintain a body to be known as the National Criminal Intelligence Service (in this Part referred to as “NCIS”).
- (2) The functions of NCIS shall be—
- to gather, store and analyse information in order to provide criminal intelligence,
 - to provide criminal intelligence to police forces in Great Britain, the [^{F9}Police Service of Northern Ireland], the National Crime Squad and other law enforcement agencies, and
 - to act in support of such police forces, the [^{F9}Police Service of Northern Ireland], the National Crime Squad and other law enforcement agencies carrying out their criminal intelligence activities.
- (3) For the purposes of subsection (2), “law enforcement agency” includes—
- any government department [^{F10}and the Scottish Administration],
 - the States of Jersey Police Force, the salaried police force of the Island of Guernsey and the Isle of Man Constabulary,
 - any other person charged with the duty of investigating offences or charging offenders, and
 - any other person engaged outside the United Kingdom in the carrying on of activities similar to any carried on by the NCIS Service Authority, NCIS, a police authority, a police force, the NCS Service Authority or the National Crime Squad.

(3B) A statutory instrument containing regulations under subsection (3A) shall be subject to annulment in pursuance of a resolution of either House of Parliament.]

3 Objectives. **U.K.**

- (1) The NCIS Service Authority shall, before the beginning of each financial year, issue a plan setting out the proposed arrangements for the carrying out by NCIS of its functions during the year (“the service plan”).
- (2) The service plan shall include a statement of the Authority’s priorities for the year, of the financial resources expected to be available and of the proposed allocation of those resources, and shall give particulars of—
 - (a) any objectives determined by the Secretary of State under section 26,
 - (b) any objectives determined by the Authority under section 3, and
 - (c) any performance targets established by the Authority, whether in compliance with a direction under section 27 or otherwise.

6 Appointment of Director General. **U.K.**

- (1) NCIS shall have a Director General appointed by the [^{F29}Secretary of State] on such terms and conditions as [^{F30}he] considers appropriate.

95 Authorisations: form and duration etc. **U.K.**
