131E Power to require information

- (1) The [F3FCA] may, by notice in writing, require a person F4...—
 - (a) to provide specified information or information of a specified description; or
 - (b) to produce specified documents or documents of a specified description.
- (2) This section applies only to information and documents that the [F3FCA] reasonably requires for the purpose of [F5the exercise by it of functions under the short selling regulation][F6or to respond to a request referred to in subsection (5A)].
- (3) Information or documents required under this section must be provided or produced—
 - (a) before the end of such reasonable period as may be specified; and
 - (b) at such place as may be specified.
- (4) The [F3FCA] may require any information provided under this section to be provided in such form as it may reasonably require.
- (5) The [F3FCA] may require—
 - (a) any information provided, whether in a document or otherwise, to be verified in such manner as it may reasonably require; or
 - (b) any document produced to be authenticated in such manner as it may reasonably require.

[The [F3FCA's] powers under this section may be exercised on a request made in the F7(5A) exercise of [F8relevant functions] by—

- [F9(a) an overseas regulator, or]
- (b) ESMA.

131FB. Entry of premises under warrant

- (1) A justice of the peace may issue a warrant under this section if satisfied on information on oath given by or on behalf of the [F³FCA] that there are reasonable grounds for believing that the conditions in subsection (2) are satisfied.

 - (d) to require any person on the premises to provide an explanation of any document or information appearing to be of the relevant kind or to state where it may be found; and
 - (e) to use such force as may be reasonably necessary.
- (4) A warrant under this section may be executed by any constable.
- (5) The warrant may authorise persons to accompany any constable who is executing it.
- (6) The powers in subsection (3) may be exercised by a person authorised by the warrant to accompany a constable; but that person may exercise those powers only in the company of, and under the supervision of, a constable.
- (7) In England and Wales, sections 15(5) to (8) and 16(3) to (12) of the Police and Criminal Evidence Act 1984 (execution of search warrants and safeguards) apply to warrants issued under this section.

131FC. Retention of documents taken under section 131FB

- (1) Any document of which possession is taken under section 131FB (“a seized document”) may be retained so long as it is necessary to retain it (rather than copies of it) in the circumstances.
- (2) A person claiming to be the owner of a seized document may apply to a magistrates’ court or (in Scotland) the sheriff for an order for the delivery of the document to the person appearing to the court or sheriff to be the owner.
- (3) If on an application under subsection (2) the court or (in Scotland) the sheriff cannot ascertain who is the owner of the seized document the court or sheriff (as the case may be) may make such order as the court or sheriff thinks fit.
- (4) An order under subsection (2) or (3) does not affect the right of any person to take legal proceedings against any person in possession of a seized document for the recovery of the document.
- (5) Any right to bring proceedings (as described in subsection (4)) may only be exercised within 6 months of the date of the order made under subsection (2) or (3).]

131G Power to impose penalty or issue censure

- (1) This section applies if the [F³FCA] is satisfied that a person has contravened—
 - (a) any provision of [F²⁷ the short selling regulation] ; or
 - (b) any requirement imposed on the person under section 131E or 131F.
- (2) The [F³FCA] may impose a penalty of such amount as it considers appropriate on—
 - (a) the person who contravened the provision or requirement; or
 - (b) any person who was knowingly concerned in the contravention.
- (3) It may, instead of imposing a penalty on a person, publish a statement censuring the person.
- (4) The [F³FCA] may not take action against a person under this section after the end of the limitation period unless, before the end of that period, it has given a warning notice to the person under section 131H.
- (5) “ The limitation period ” means the period of three years beginning with the first day on which the [F³FCA] knew of the contravention.
- (6) For this purpose the [F³FCA] is to be treated as knowing of a contravention if it has information from which the contravention can reasonably be inferred.

131H Procedure and right to refer to Tribunal

- (1) If the [F³FCA] proposes to take action against a person under section 131G, it must give the person a warning notice.
- (2) A warning notice about a proposal to impose a penalty must state the amount of the penalty.

131J Imposition of penalties under section 131G: statement of policy

- (1) The [F³FCA] must prepare and issue a statement of its policy with respect to—
 - (a) the imposition of penalties under section 131G; and
 - (b) the amount of penalties under that section.
- (2) The [F³FCA's] policy in determining what the amount of a penalty should be must include having regard to—
 - (a) the seriousness of the contravention;
 - (b) the extent to which the contravention was deliberate or reckless; and
 - (c) whether the person on whom the penalty is to be imposed is an individual.
- (3) The [F³FCA] may at any time alter or replace a statement issued under this section.
- (4) If a statement issued under this section is altered or replaced, the [F³FCA] must issue the altered or replaced statement.
- (5) The [F³FCA] must, without delay, give the Treasury a copy of any statement which it publishes under this section.
- (6) A statement issued under this section must be published by the [F³FCA] in the way appearing to the [F³FCA] to be best calculated to bring it to the attention of the public.

131K Statement of policy: procedure

- (1) Before issuing a statement under section 131J, the [F³FCA] must publish a draft of the proposed statement in the way appearing to the [F³FCA] to be best calculated to bring it to the attention of the public.
- (2) The draft must be accompanied by notice that representations about the proposal may be made to the [F³FCA] within a specified time.
- (3) Before issuing the proposed statement, the [F³FCA] must have regard to any representations made to it in accordance with subsection (2).
- (4) If the [F³FCA] issues the proposed statement it must publish an account, in general terms, of—
 - (a) the representations made to it in accordance with subsection (2); and
 - (b) its response to them.
- (5) If the statement differs from the draft published under subsection (1) in a way which is, in the opinion of the [F³FCA], significant, the [F³FCA] must (in addition to complying with subsection (4)) publish details of the difference.
- (6) The [F³FCA] may charge a reasonable fee for providing a person with a copy of a draft published under subsection (1).
- (7) This section also applies to a proposal to alter or replace a statement.]

- (1) If a relevant person (“A”) fails to comply with a requirement imposed on A under section 131E or 131F the [F³FCA] may certify that fact in writing to the court.
- (2) If the court is satisfied that A failed without reasonable excuse to comply with the requirement, it may deal with A (and where A is a body corporate, any director or officer) as if A (or as the case may be the director or officer) were in contempt; and “officer”, in relation to a limited liability partnership, means a member of the limited liability partnership.
