Powers to gather information

- 165** [^{F1}Regulators] power to require information [^{F2}: authorised persons etc]. **U.K.**
- (1) [^{F3}Either regulator] may, by notice in writing given to an authorised person, require him—
 - (a) to provide specified information or information of a specified description; or
 - (b) to produce specified documents or documents of a specified description.
 - (2) The information or documents must be provided or produced—
 - (a) before the end of such reasonable period as may be specified; and
 - (b) at such place as may be specified.
 - (3) An officer who has written authorisation from the [^{F4}regulator] to do so may require an authorised person without delay—
 - (a) to provide the officer with specified information or information of a specified description; or
 - (b) to produce to him specified documents or documents of a specified description.
 - (4) This section applies only to
 - [^{F5}(a)] information and documents reasonably required in connection with the exercise by [^{F6}either regulator] of functions conferred on it by or under this Act [^{F7}, and
 - (b) in relation to the exercise by the PRA of the powers conferred by subsections (1) and (3), information and documents reasonably required by the Bank of England in connection with the exercise by the Bank of its functions in pursuance of its financial stability objective.]
 - (5) [^{F8}The regulator in question] may require any information provided under this section to be provided in such form as it may reasonably require.
 - (6) [^{F9}The regulator in question] may require—
 - (a) any information provided, whether in a document or otherwise, to be verified in such manner, or
 - (b) any document produced to be authenticated in such manner,

[^{F19}165A][^{F20}PRA's] power to require information: financial stability **U.K.**

- (1) The [^{F21}PRA] may, by notice in writing given to a person to whom this section applies, require the person—
- to provide specified information or information of a specified description; or
 - to produce specified documents or documents of a specified description.
- (2) This section applies to—
- a person who has a legal or beneficial interest in any of the assets of a relevant investment fund;
 - a person who is responsible for the management of a relevant investment fund;
 - a person (a “service provider”) who provides any service to an authorised person;
 - a person prescribed by an order made by the Treasury or any person of a description prescribed by such an order (and see also section 165C);
 - a person who is connected with a person to whom this section applies as a result of any of the above paragraphs.
- (3) This section applies only to
- [^{F22}(a)] information and documents that the [^{F21}PRA] considers are, or might be, relevant to the stability of one or more aspects of the UK financial system [^{F23}, and
 - information and documents reasonably required by the Bank of England in connection with the exercise by the Bank of its functions in pursuance of its financial stability objective.]
- (4) A notice may be given to a service provider, or to a person who is connected with a service provider, only if the [^{F21}PRA] considers that—
- the service or the way in which it (or any part of it) is provided, or
 - any failure to provide the service (or any part of it),
- poses, or would be likely to pose, a serious threat to the stability of the UK financial system.

165B Safeguards etc in relation to exercise of power under section 165A **U.K.**

- (1) If the [F²⁵PRA] proposes to impose a requirement on a person under section 165A, it must give the person a notice in writing warning the person that the [F²⁵PRA] is proposing to impose the requirement.
- (2) The notice under subsection (1) must—
 - (a) give the [F²⁶PRA's] reasons for proposing to impose the requirement; and
 - (b) specify a reasonable period within which the person may make representations to the [F²⁵PRA].
- (3) The [F²⁵PRA] must then decide, within a reasonable period, whether to impose the requirement.
- (4) Subsections (1) to (3) do not apply in any case where the [F²⁵PRA] is satisfied that it is necessary for the information or documents to be provided or produced without delay.
- (5) If the [F²⁵PRA] imposes a requirement on a person under section 165A, the notice under that section must give the [F²⁶PRA's] reasons for imposing the requirement.
- (6) The [F²⁵PRA] must prepare a statement of its policy with respect to the exercise of the power conferred by section 165A.
- (7) The statement requires the approval of the Treasury.
- (8) If the Treasury approve the statement, the [F²⁵PRA] must publish it.
- (9) The power conferred by section 165A may not be exercised before the statement has been published.

175 Information and documents: supplemental provisions. **U.K.**

177 Offences. **U.K.**

- (1) If a person other than the investigator (“the defaulter”) fails to comply with a requirement imposed on him under this Part the person imposing the requirement may certify that fact in writing to the court.
- (2) If the court is satisfied that the defaulter failed without reasonable excuse to comply with the requirement, it may deal with the defaulter (and in the case of a body corporate, any director or [^{F99}other] officer) as if he were in contempt [^{F100}; and “officer”, in relation to a limited liability partnership, means a member of the limited liability partnership.].
- (3) A person who knows or suspects that an investigation is being or is likely to be conducted under this Part is guilty of an offence if—
- he falsifies, conceals, destroys or otherwise disposes of a document which he knows or suspects is or would be relevant to such an investigation, or
 - he causes or permits the falsification, concealment, destruction or disposal of such a document,
- unless he shows that he had no intention of concealing facts disclosed by the documents from the investigator.
- (4) A person who, in purported compliance with a requirement imposed on him under this Part—
- provides information which he knows to be false or misleading in a material particular, or
