380 Injunctions.

- (1) If, on the application of the [^{F1}appropriate regulator] or the Secretary of State, the court is satisfied—
- (a) that there is a reasonable likelihood that any person will contravene a relevant requirement, or

- (b) that any person has contravened a relevant requirement and that there is a reasonable likelihood that the contravention will continue or be repeated, the court may make an order restraining (or in Scotland an interdict prohibiting) the contravention.
- (2) If on the application of the [F1 appropriate regulator] or the Secretary of State the court is satisfied—
- (a) that any person has contravened a relevant requirement, and
- (b) that there are steps which could be taken for remedying the contravention, the court may make an order requiring that person, and any other person who appears to have been knowingly concerned in the contravention, to take such steps as the court may direct to remedy it.
- (3) If, on the application of the [F1 appropriate regulator] or the Secretary of State, the court is satisfied that any person may have—
- (a) contravened a relevant requirement, or
- (b) been knowingly concerned in the contravention of such a requirement, it may make an order restraining (or in Scotland an interdict prohibiting) him from disposing of, or otherwise dealing with, any assets of his which it is satisfied he is reasonably likely to dispose of or otherwise deal with.
- (4) The jurisdiction conferred by this section is exercisable by the High Court and the Court of Session.
- (5) In subsection (2), references to remedying a contravention include references to mitigating its effect.

381 Injunctions in cases of market abuse.

- (1) If, on the application of the ^[F15]FCA, the court is satisfied—
- (a) that there is a reasonable likelihood that any person will ^[F16]contravene Article 14 (prohibition of insider dealing and of unlawful disclosure of inside information) or Article 15 (prohibition of market manipulation) of the market abuse regulation], or
 - (b) that any person is or has ^[F17]contravened Article 14 or 15 of the market abuse regulation] and that there is a reasonable likelihood that the ^[F18]contravention] will continue or be repeated,
- the court may make an order restraining (or in Scotland an interdict prohibiting) the ^[F19]contravention].

382 Restitution orders.

- (1) The court may, on the application of the [^{F26}appropriate regulator] or the Secretary of State, make an order under subsection (2) if it is satisfied that a person has contravened

- (a) that profits have accrued to him as a result of the contravention; or
 - (b) that one or more persons have suffered loss or been otherwise adversely affected as a result of the contravention.
- (2) The court may order the person concerned to pay to the [^{F27}regulator concerned] such sum as appears to the court to be just having regard—
- (a) in a case within paragraph (a) of subsection (1), to the profits appearing to the court to have accrued;
 - (b) in a case within paragraph (b) of that subsection, to the extent of the loss or other adverse effect;
 - (c) in a case within both of those paragraphs, to the profits appearing to the court to have accrued and to the extent of the loss or other adverse effect.
- (3) Any amount paid to the [^{F28}regulator concerned] in pursuance of an order under subsection (2) must be paid by it to such qualifying person or distributed by it among such qualifying persons as the court may direct.

- (a) establishing whether any and, if so, what profits have accrued to him as mentioned in paragraph (a) of that subsection;
 - (b) establishing whether any person or persons have suffered any loss or adverse effect as mentioned in paragraph (b) of that subsection and, if so, the extent of that loss or adverse effect; and
 - (c) determining how any amounts are to be paid or distributed under subsection (3).
