#### ROLE OF THE COMPETITION COMMISSION

##### *Consideration of matters arising on a report*

- 2 In considering any matter arising from a report made by the [<sup>F1</sup>OFT] under section 160, the Commission must have regard to—
- (a) any representations made to [<sup>F2</sup>the Commission] in connection with the matter by any person appearing to the Commission to have a substantial interest in the matter; and
  - (b) any cost benefit analysis prepared by the Authority (at any time) in connection with the regulatory provision or practice, or any of the regulatory provisions or practices, which are the subject of the report.
