Insolvency etc.

157 Manager of [^{F1}registered society]: extra powers

- (1) This section applies to a manager appointed to implement proposals relating to [^{F2}a registered society].
- (2) The appointment may confer on the manager power to make and execute on behalf of the society—
 - (a) an instrument providing for the amalgamation of the society with another [^{F1}registered society], or
 - (b) an instrument transferring its engagements.
- (3) An instrument providing for the amalgamation of a society (“S1”) with another has the same effect as a resolution by S1 under [^{F3}section 109 of the Co-operative and Community Benefit Societies Act 2014] (amalgamation of societies by special resolution).
- (4) An instrument transferring engagements has the same effect as a transfer of engagements under [^{F4}section 110 or 112 of the Co-operative and Community Benefit Societies Act 2014] (transfer by special resolution to another society or company).
- (5) A copy of the instrument shall be sent to and registered by the [^{F5}Financial Conduct Authority].

- (6) An instrument does not take effect until the copy is registered.
- (7) The copy must be sent for registration during the period of 14 days beginning with the date of execution; but a copy registered after that period is valid.
