



# Crime (Overseas Production Orders) Act 2019

## 2019 CHAPTER 5

### *Supplementary*

#### **9 Restrictions on service of order**

- (1) An overseas production order that is not served within the period of 3 months beginning with the day on which the order is made is to be treated as if it had been quashed immediately after the end of that period.
- (2) An overseas production order made in England and Wales or Northern Ireland may be served only by the Secretary of State [<sup>F1</sup>or a prescribed person].
- (3) An overseas production order made in Scotland may be served only by the Lord Advocate [<sup>F2</sup>or a prescribed person].
- (4) [<sup>F3</sup>A person] may serve an overseas production order only if [<sup>F4</sup>that person] considers that to do so would be in accordance with a designated international co-operation arrangement.
- [<sup>F5</sup>(5) In this section “prescribed person”—
  - (a) in relation to an overseas production order made in England and Wales or Northern Ireland, means a person prescribed by regulations made by the Secretary of State;
  - (b) in relation to an overseas production order made in Scotland, means a person prescribed by regulations made by the Lord Advocate.]
