# 48 Jurisdiction of courts-martial.

- (1) Subject to the provisions of this section, any offence under Part I of this Act may be tried and punished by court-martial; and a court-martial shall have jurisdiction to try any such offence whether committed within the United Kingdom or elsewhere.
- (2) A person shall not be tried by court-martial by virtue of section forty-two of this Act for a civil offence of treason, murder, manslaughter, treason-felony <sup>F1</sup>... [<sup>F2</sup>or an offence under section 1 of the Geneva Conventions Act 1957]... [<sup>F3</sup>or an offence under section 2 or 11 of the Chemical Weapons Act 1996][<sup>F5</sup>or an offence under section 51 or 52 of the International Criminal Court Act 2001]committed on shore within the United Kingdom; and for the purposes of this subsection an offence of murder or manslaughter [<sup>F6</sup>, or an offence under section 1 of the Killing of a person,]...shall be deemed to have been committed at the place of the commission of the act or the occurrence of the neglect which caused the death, irrespective of the place of the death. [<sup>F7</sup>In this subsection the references to murder shall apply also to aiding, abetting, counselling or procuring suicide].

# 52 Limitation of time for trial.

- [<sup>F12</sup>(1) Where by virtue of any enactment proceedings on indictment for any civil offence must be brought within a limited period, a person shall not be tried for that offence under section 42 of this Act unless the trial is begun within that period.]
  - (2) Without prejudice to the foregoing subsection, but subject to the provisions of subsection (3) of this section, a person shall not be tried by virtue of section fifty-one of this Act for an offence committed while subject to this Act unless the trial is begun within three months [<sup>F13</sup>or, in the case of trial by court-martial, six months] after he ceased to be subject thereto.
