### 1933 CHAPTER 12 23 and 24 Geo 5

### PART I

PREVENTION OF CRUELTY AND EXPOSURE TO MORAL AND PHYSICAL DANGER

### Offences

### 1 Cruelty to persons under sixteen.

- (1) If any person who has attained the age of sixteen years and [FI has responsibility for] any child or young person under that age, wilfully assaults, ill-treats, neglects, abandons, or exposes him, or causes or procures him to be assaulted, ill-treated, neglected, abandoned, or exposed, in a manner likely to cause him unnecessary suffering or injury to health (including injury to or loss of sight, or hearing, or limb, or organ of the body, and any mental derangement), that person shall be guilty of a misdemeanor, and shall be liable—
  - (a) on conviction on indictment, to a fine . . . <sup>F2</sup> or alternatively, . . . <sup>F3</sup>, or in addition thereto, to imprisonment for any term not exceeding [F4ten] years;
  - (b) on summary conviction, to a fine not exceeding [F5£400] pounds, or alternatively, . . . F3, or in addition thereto, to imprisonment for any term not exceeding six months.

### (2) For the purposes of this section—

- (a) a parent or other person legally liable to maintain a child or young person [<sup>F6</sup>, or the legal guardian of a child or young person,] shall be deemed to have neglected him in a manner likely to cause injury to his health if he has failed to provide adequate food, clothing, medical aid or lodging for him, or if, having been unable otherwise to provide such food, clothing, medical aid or lodging, he has failed to take steps to procure it to be provided under [<sup>F7</sup>the enactments applicable in that behalf];
- (b) where it is proved that the death of an infant under three years of age was caused by suffocation (not being suffocation caused by disease or the presence of any foreign body in the throat or air passages of the infant) while the infant

was in bed with some other person who has attained the age of sixteen years, that other person shall, if he was, when he went to bed, under the influence of drink, be deemed to have neglected the infant in a manner likely to cause injury to its health.

- (3) A person may be convicted of an offence under this section—
  - (a) notwithstanding that actual suffering or injury to health, or the likelihood of actual suffering or injury to health, was obviated by the action of another person;
  - (b) notwithstanding the death of the child or young person in question.

### 3 Allowing persons under sixteen to be in brothels.

(1) If any person having [F12 responsibility for] a child or young person who has attained the age of four years and is under the age of sixteen years, allows that child or young person to reside in or to frequent a brothel, he shall be [F13 liable on summary conviction to a fine not exceeding [F14 level 2 on the standard scale]], or alternatively . . . F15 or in addition thereto, to imprisonment for any term not exceeding six months.

### 4 Causing or allowing persons under sixteen to be used for begging.

- (1) If any person causes or procures any child or young person under the age of sixteen years or, having [F17 responsibility for] such a child or young person, allows him to be in any street, premises, or place for the purpose of begging or receiving alms, or of inducing the giving of alms (whether or not there is any pretence of singing, playing, performing, offering anything for sale, or otherwise) he shall, on summary conviction, be liable to a fine not exceeding [F18 level 2 on the standard scale], or alternatively, . . . F19 or in addition thereto, to imprisonment for any term not exceeding three months.
- (2) If a person having [F17 responsibility for] a child or young person is charged with an offence under this section, and it is proved that the child or young person was in any street, premises, or place for any such purpose as aforesaid, and that the person charged allowed the child or young person to be in the street, premises, or place, he shall be presumed to have allowed him to be in the street, premises, or place for that purpose unless the contrary is proved.
- (3) If any person while singing, playing, performing or offering anything for sale in a street or public place has with him a child who has been lent or hired out to him, the child shall, for the purposes of this section, be deemed to be in that street or place for the purpose of inducing the giving of alms.

### 5 Giving intoxicating liquor to children under five.

If any person gives, or causes to be given, to any child under the age of five years any [F20] alcohol (within the meaning given by section 191 of the Licensing Act 2003, but disregarding subsection (1)(f) to (i) of that section)], except upon the order of a duly qualified medical practitioner, or in case of sickness, apprehended sickness, or other urgent cause, he shall, on summary conviction, be liable to a fine not exceeding [F21] level 1 on the standard scale].

## 7 Sale of tobacco, &c. to persons under [F23 eighteen].

- (1) Any person who sells to a person [F24. . .] under the age of [F25eighteen] years any tobacco or cigarette papers, whether for his own use or not, shall be liable, [F26on summary conviction to a fine not exceeding level 4 on the standard scale.]
- [F27(1A) It shall be a defence for a person charged with an offence under subsection (1) above to prove that he took all reasonable precautions and exercised all due diligence to avoid the commission of the offence.]
  - (2) If on complaint to a [F28 magistrates' court] it is proved to the satisfaction of the court that any automatic machine for the sale of tobacco kept on any premises [F29 has been used by any person] under the age of [F25 eighteen] years, the court [F30 shall] order the owner of the machine, or the person on whose premises the machine is kept, to take such precautions to prevent the machine being so used as may be specified in the order or, if necessary, to remove the machine, within such time as may be specified in the order, and if any person against whom such an order has been made fails to comply therewith, he shall be liable, on summary conviction, [F31 to a fine not exceeding level 4 on the standard scale.]
  - (3) It shall be the duty of a constable and of a park-keeper being in uniform to seize any tobacco or cigarette papers in the possession of any person apparently under the age of sixteen years whom he finds smoking in any street or public place, and any tobacco or cigarette papers so seized shall be disposed of, if seized by a constable, in such manner as the police authority may direct, and if seized by a park-keeper, in such manner as the authority or person by whom he was appointed may direct.
  - (4) Nothing in this section shall make it an offence to sell tobacco or cigarette papers to, or shall authorise the seizure of tobacco or cigarette papers in the possession of, any person who is at the time employed by a manufacturer of or dealer in tobacco, either wholesale or retail, for the purposes of his business, or is a boy messenger in uniform in the employment of a messenger company and employed as such at the time.
  - (5) For the purposes of this section the expression "tobacco" includes cigarettes [F32 any product containing tobacco and intended for oral or nasal use] and smoking mixtures intended as a substitute for tobacco, and the expression "cigarettes" includes cut tobacco rolled up in paper, tobacco leaf, or other material in such form as to be capable of immediate use for smoking.

### †Exposing children under seven to risk of burning.

If any person who has attained the age of sixteen years, having [F36 responsibility for] any child under the age of [F37 twelve] years, allows the child to be in any room containing an open fire grate [F38 or any heating appliance liable to cause injury to a person by contact therewith] not sufficiently protected to guard against the risk of his being burnt or scalded without taking reasonable precautions against that risk, and by reason thereof the child is killed or suffers serious injury, he shall on summary conviction be liable to a fine not exceeding [F39] level 1 on the standard scale]:

Provided that neither this section, not any proceedings taken thereunder, shall affect any liability of any such person to be proceeded against by indictment for any indictable offence.

### Failing to provide for safety of children at entertainments.

- (1) Where there is provided in any building an entertainment for children, or an entertainment at which the majority of the persons attending are children, then, if the number of children attending the entertainment exceeds one hundred, it shall be the duty of the person providing the entertainment to station and keep stationed wherever necessary a sufficient number of adult attendants, properly instructed as to their duties, to prevent more children or other persons being admitted to the building, or to any part thereof, than the building or part can properly accommodate, and to control the movement of the children and other persons admitted while entering and leaving the building or any part thereof, and to take all other reasonable precautions for the safety of the children.
- (2) Where the occupier of a building permits, for hire or reward, the building to be used for the purpose of an entertainment, he shall take all reasonable steps to secure the observance of the provisions of this section.
- (3) If any person on whom any obligation is imposed by this section fails to fulfil that obligation, he shall be liable, on summary conviction, to a fine not exceeding, in the case of a first offence fifty pounds, and in the case of a second or subsequent offence one hundred pounds <sup>F40</sup>. . . .
- (4) A constable may enter any building in which he has reason to believe that such an entertainment as aforesaid is being, or is about to be, provided, with a view to seeing whether the provisions of this section are carried into effect, and an officer authorised for the purpose by an authority by whom licences are granted under any of

the enactments referred to in the last foregoing subsection shall have the like power of entering any building so licensed by that authority.

- (5) The institution of proceedings under this section shall—
  - $[^{F41}(a)]$ in the case of a building in respect of which a premises licence authorising the provision of regulated entertainment has effect, be the duty of the relevant licensing authority;]
    - in any other case, be the duty of the police authority.

### [F42(5A) For the purposes of this section—

- "the relevant licensing authority", in relation to a building in respect of which a premises licence has effect, means the relevant licensing authority in relation to that building under section 12 of that Act.]

### 12A **Restricted premises orders**

(1) This section applies where a person ("the offender") is convicted of a tobacco offence ("the relevant offence").

- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted premises order to be made in respect of the premises in relation to which that offence was committed ("the relevant premises").
- (3) A restricted premises order is an order prohibiting the sale on the premises to which it relates of any tobacco or cigarette papers to any person.
- (4) The prohibition applies to sales whether made—
  - (a) by the offender or any other person, or
  - (b) by means of any machine kept on the premises or any other means.
- (5) The order has effect for the period specified in the order, but that period may not exceed one year.
- (6) The applicant must, after making reasonable enquiries, give notice of the application to every person appearing to the applicant to be a person affected by it.
- (7) The court may make the order if (and only if) it is satisfied that—
  - (a) on at least 2 occasions within the period of 2 years ending with the date on which the relevant offence was committed, the offender has committed other tobacco offences in relation to the relevant premises, and
  - (b) the applicant has complied with subsection (6).
- (8) Persons affected by the application may make representations to the court as to why the order should not be made.
- (9) If—
  - (a) a person affected by an application for a restricted premises order was not given notice under subsection (6), and
  - (b) consequently the person had no opportunity to make representations to the court as to why the order should not be made,

the person may by complaint apply to the court for an order varying or discharging it.

- (10) On an application under subsection (9) the court may, after hearing—
  - (a) that person, and
  - (b) the applicant for the restricted premises order,

make such order varying or discharging the restricted premises order as it considers appropriate.

- (11) For the purposes of this section the persons affected by an application for a restricted premises order in respect of any premises are—
  - (a) the occupier of the premises, and
  - (b) any other person who has an interest in the premises.

### 12B Restricted sale orders

- (1) This section applies where a person ("the offender") is convicted of a tobacco offence ("the relevant offence").
- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted sale order to be made in respect of the offender.

- (3) A restricted sale order is an order prohibiting the person to whom it relates
  - from selling any tobacco or cigarette papers to any person,
  - from having any management functions in respect of any premises in so far as those functions relate to the sale on the premises of tobacco or cigarette papers to any person,
  - (c) from keeping any cigarette machine on any premises for the purpose of selling tobacco or permitting any cigarette machine to be kept on any premises by any other person for that purpose, and
  - from having any management functions in respect of any premises in so far as those functions relate to any cigarette machine kept on the premises for the purpose of selling tobacco.
- (4) The order has effect for the period specified in the order, but that period may not exceed one year.
- (5) The court may make the order if (and only if) it is satisfied that, on at least 2 occasions within the period of 2 years ending with the date on which the relevant offence was committed, the offender has committed other tobacco offences.
- (6) In this section any reference to a cigarette machine is a reference to an automatic machine for the sale of tobacco.

### 12C **Enforcement**

- (1) If
  - a person sells on any premises any tobacco or cigarette papers in contravention of a restricted premises order, and
  - the person knew, or ought reasonably to have known, that the sale was in contravention of the order,

the person commits an offence.

- (2) If a person fails to comply with a restricted sale order, the person commits an offence.
- (3) It is a defence for a person charged with an offence under subsection (2) to prove that the person took all reasonable precautions and exercised all due diligence to avoid the commission of the offence.
- (4) A person guilty of an offence under this section is liable, on summary conviction, to a fine not exceeding £20,000.
- (5) A restricted premises order is a local land charge and in respect of that charge the applicant for the order is the originating authority for the purposes of the Local Land Charges Act 1975.

### 12D Interpretation

- (1) In sections 12A and 12B a "tobacco offence" means
  - an offence committed under section 7(1) on any premises (which are accordingly "the premises in relation to which the offence is committed"), or
  - an offence committed under section 7(2) in respect of an order relating to any machine kept on any premises (which are accordingly "the premises in relation to which the offence is committed").

# [F18549 Restrictions on reports of proceedings in which children or young persons are concerned.

- (1) The following prohibitions apply (subject to subsection (5) below) in relation to any proceedings to which this section applies, that is to say—

  - (a) proceedings in a youth court;

  - (d) proceedings on appeal from a magistrates' court arising out of proceedings under [F187]Schedule 7 to that Act](including proceedings by way of case stated).

- (4) For the purposes of this section a child or young person is "concerned" in any proceedings whether as being the person against or in respect of whom the proceedings are taken or as being a witness in the proceedings.
- [ If a court is satisfied that it is in the public interest to do so, it may, in relation to a first (4A) child or young person who has been convicted of an offence, by order dispense to any specified extent with the requirements of this section in relation to any proceedings before it to which this section applies by virtue of subsection (2)(a) or (b) above, being proceedings relating to—
  - (a) the prosecution or conviction of the offender for the offence;
  - (b) the manner in which he, or his parent or guardian, should be dealt with in respect of the offence;
  - (c) the enforcement, amendment, variation, revocation or discharge of any order made in respect of the offence;
  - (d) where an attendance centre order is made in respect of the offence, the enforcement of any rules made under [F189] section 222(1)(d) or (e) of the Criminal Justice Act 2003]; or

- where a detention and training order is made, the enforcement of any requirements imposed under [F191 section 103(6)(b) of the Powers of Criminal Courts (Sentencing) Act 2000].]
- (4B) A court shall not exercise its power under subsection (4A) above without—
  - (a) affording the parties to the proceedings an opportunity to make representations; and

# Power of Secretary of State to send certain juvenile offenders to approved schools.

The Secretary of State may by order direct that—

- (a) a person who is under the age of eighteen years and is undergoing detention in a Borstal institution; or
- (b) a child or young person [F203] sentenced to be detained under section 91 of the Powers of Criminal Courts (Sentencing) Act 2000 with respect to whom he is authorised to give directions under section 92 of that Act]; or

- (1) The managers of any school intended for the education and training of persons to be sent there in pursuance of this Act may apply to the Secretary of State to approve the school for that purpose, and the Secretary of State may, after making such inquiries as he thinks fit, approve the school for that purpose and issue a certificate of approval to the managers.

# F22280 Provision of approved schools by local authorities.

(1) A local authority may, with the approval of the Secretary of State, undertake, or combine with any other local authority in undertaking, or contribute such sums of money upon such conditions as they may think fit towards, the purchase, establishment, building, alteration, enlargement, rebuilding or management of an approved school:

Provided that, before giving his approval, the Secretary of State shall satisfy himself that the proposed expenditure is reasonable and, where it is proposed to purchase, build or establish a new school, that there is a deficiency of approved school accommodation which cannot properly be remedied in any other way.

(2) In the event of a deficiency of approved school accommodation, it shall be the duty of every local authority concerned to take, either alone or in combination with other local authorities, appropriate steps under this section to remedy the deficiency.
