Trust (Transfer of Trust Property) Order 1992**

The Secretary of State for Health, in exercise of the powers conferred by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling her in that behalf, having regard to the change in the arrangements for the administration of hospitals and facilities formerly managed by Wirral Health Authority resulting from the establishment of the Wirral Hospital National Service Trust(2), having consulted that Health Authority and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Wirral Hospital National Health Service Trust (Transfer of Trust Property) Order 1992 and shall come into force on 5th June 1992.

(2) In this Order:

“the Authority” means Wirral Health Authority;

“the Trust” means the Wirral Hospital National Health Service Trust;

“the trust property” means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 7th March 1992 which schedule has been signed on behalf of both the Authority and the Trust.

**Transfer of Trust Property**

2. On 5th June the trust property shall be transferred from the Authority to the Trust.
