The Optimum Health Services National Health Service Trust (Transfer of Trust Property) Order 1996

Made - - - - 1996

Laid before Parliament 30th September 1996

Coming into force - - 21st October 1996

The Secretary of State for Health, in exercise of the powers conferred on him by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling him in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by the Lewisham and North Southwark Health Authority resulting from the establishment of the Optimum Health Services National Health Service Trust(2), having consulted the South East London Health Authority(3) and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Optimum Health Services National Health Service Trust (Transfer of Trust Property) Order 1996 and shall come into force on 21st October 1996.
 - (2) In this Order—
 - "the Authority" means the Lambeth, Southwark and Lewisham Health Authority established on 1st April 1996(4);
 - "the old Authority" means the South East London Health Authority established on 1st April 1993(5) and abolished on 1st April 1996(6);
 - "the Trust" means the Optimum Health Services National Health Service Trust;
