**The National Health Service (Primary Care)  
Act 1997 (Commencement No. 2) Order 1997**

*Made - - - - 13th October 1997*

The Secretary of State, in exercise of powers conferred on him by section 41(3) and (4) of the National Health Service (Primary Care) Act 1997<sup>(1)</sup> and of all other powers enabling him in that behalf, hereby makes the following Order:—

**Citation**

1. This Order may be cited as the National Health Service (Primary Care) Act 1997 (Commencement No. 2) Order 1997.

**Appointed day**

2. The day appointed for the coming into force of section 36 of the National Health Service (Primary Care) Act 1997 (expenditure of Health Authorities) is 14th October 1997.

**Saving**

3. Notwithstanding article 2, in relation to—

- (a) expenditure of Health Authorities in respect of a financial year ending on 31st March 1998 or before; and
- (b) amounts allotted to Health Authorities in respect of such a financial year,

section 97 of the National Health Service Act 1977<sup>(2)</sup> shall continue to have effect as if this Order had not been made.
