BETTING, GAMING AND LOTTERIES

The Gaming Act (Variation of Fees) Order 1998

Made - - - - *24th February 1998*
Laid before Parliament *4th March 1998*
Coming into force - - *1st April 1998*

The Secretary of State, in pursuance of the powers conferred on him by sections 48(5) and 51(4) of the Gaming Act 1968(1), hereby makes the following Order:

1. This Order may be cited as the Gaming Act (Variation of Fees) Order 1998 and shall come into force on 1st April 1998.

2. The provisions of section 48 of the Gaming Act 1968 specified in column 1 of the Schedule to this Order (which relate to fees charged in relation to the matters mentioned in column 2 of that Schedule) shall have effect as if, for the references to the sums specified in those provisions (which, by virtue of the Gaming Act (Variation of Fees) Order 1995(2) as respects England and Wales and the Gaming Act (Variation of Fees) (Scotland) Order 1995(3) as respects Scotland, had effect immediately before the coming into force of this Order as if, for those references, there were substituted references to the sums specified in column 3 of that Schedule), there were substituted references to the sums specified in column 4 of that Schedule.

3. The Gaming Act (Variation of Fees) Order 1995 and the Gaming Act (Variation of Fees) (Scotland) Order 1995 are hereby revoked.
