The City and Hackney Community Services, the Newham Community Health Services and the Tower Hamlets Healthcare National Health Service Trusts (Dissolution) Order 2001

Made - - - - 25th February2001

Coming into force - - 1st April 2001

The Secretary of State for Health, in exercise of the powers conferred on him by section 126(3) of the National Health Service Act 1977(1) and by section 5(1) of, and paragraph 29(1) of Schedule 2 to, the National Health Service and Community Care Act 1990(2) and of all other powers enabling him in that behalf, considering it appropriate in the interests of the health service to make this Order(3), and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act(4), hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the City and Hackney Community Services, the Newham Community Health Services and the Tower Hamlets Healthcare National Health Service Trusts (Dissolution) Order 2001 and shall come into force on 1st April 2001.

Dissolution of NHS trusts

- **2.**—(1) The City and Hackney Community Services National Health Service Trust established by the City and Hackney Community Services National Health Service Trust (Establishment) Order 1995(5) is hereby dissolved, and accordingly that Order is hereby revoked.
- (2) The Newham Community Health Services National Health Service Trust established by the Newham Community Health Services National Health Service Trust (Establishment) Order 1995(6) is hereby dissolved, and accordingly that Order is hereby revoked.
