

## SCHEDULE 4

Regulation 20 and paragraph 35 of

### PATIENT INFORMATION LEAFLET

A patient leaflet shall include—

1. The name of the party or parties comprising the contractor.
2. In the case of an agreement with [<sup>F1</sup>a dental corporation]—
  - (a) the names of the directors, chief executive and secretary of [<sup>F2</sup>that corporation], in so far as those positions exist in relation to [<sup>F3</sup>the dental corporation]; and
  - (b) the address of [<sup>F4</sup>the corporation's] registered office.

- 7. The contractor's telephone and fax numbers and the address of its website (if any).
- 8. Whether the practice premises have suitable access for disabled patients and, if not, the alternative arrangements for providing services to such patients.
- 9. How to request services as a patient.
- 10. The rights of a patient to express a preference of practitioner in accordance with paragraph 2 of Schedule 3 and the means of expressing such a preference.
- 11. The services available under the agreement.
- 12. The normal surgery days and hours of the practice.
- 13. The arrangements for [<sup>F6</sup>dental services for the] hours and days that fall outside normal surgery hours (whether or not provided by the contractor) and how the patient may contact such services.
