- **1.** This Order may be cited as the Serious Organised Crime and Police Act 2005 (Commencement) (No. 7) Order 2006.
- **2.** Section 144 of and Schedule 10 to the Serious Organised Crime and Police Act 2005 (parental compensation orders)(**2**) shall come into force on 20th July 2006 in the areas specified in the Schedule to this Order.
