**The Immigration Act 2014 (Commencement No. 5) Order 2015**

*Made* - - - - *23rd March 2015*

The Secretary of State, in exercise of the powers conferred by sections 73(1) and 75(3) of the Immigration Act 2014<sup>(1)</sup>, makes the following Order:

**Citation**

1. This Order may be cited as the Immigration Act 2014 (Commencement No. 5) Order 2015.

**Provisions coming into force on 6th April 2015**

2. The day appointed for the coming into force of the following provisions of the Immigration Act 2014 is 6th April 2015—

- (a) section 39 (related provision: charges for health services);
- (b) section 73(6) (transitional and consequential provision) so far as is necessary for the purpose of the provision listed in sub-paragraph (c); and
- (c) Part 9 of Schedule 9 (provision relating to persons unable to acquire nationality because natural father not married to mother).
