Revocation of Regulation (EU) 2019/26 and transitional provision

10A.—(1) Regulation (EU) 2019/26 of the European Parliament and of the Council of 8 January 2019 complementing Union type-approval legislation with regard to the withdrawal of the United Kingdom from the Union—

- (a) is revoked; and
- (b) is to be treated as though it never formed part of retained EU law.

(2) Any valid UK type-approval (as defined in Article 3(2) of Regulation (EU) 2019/26 of the European Parliament and of the Council of 8 January 2019 complementing Union type-approval legislation with regard to the withdrawal of the United Kingdom from the Union ^{F2}, as it had effect in EU law before [^{F3}IP completion day]) existing immediately before [^{F3}IP completion day]—

- (a) to the extent it is rendered invalid by—
 - (i) the third sentence of Article 5(5) of that Regulation; or
 - (ii) the third sentence of Article 5(5) of that Regulation as it formed part of retained EU law (but for the operation of paragraph (1)) on [^{F3}IP completion day],is revived; and
- (b) continues to be valid on and after [^{F3}IP completion day].]
