**The Conformity Assessment (Mutual Recognition Agreements)
(Construction Products) (Amendment) Regulations 2021**

Made - - - - 26th November 2021

Coming into force - - 27th November 2021

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 2(1) and (9)(b) and 4(1)(b) of the Trade Act 2021⁽¹⁾.

In accordance with paragraph 4(1) of Schedule 2 to the Trade Act 2021 a draft of this instrument has been laid before Parliament and approved by a resolution of each House of Parliament.

Citation and commencement

1. These Regulations may be cited as the Conformity Assessment (Mutual Recognition Agreements) (Construction Products) (Amendment) Regulations 2021 and come into force on the day after the day on which these Regulations are made.

Extent

2. These Regulations extend to England and Wales, Scotland and Northern Ireland.

Amendment of the Conformity Assessment (Mutual Recognition Agreements) and Weights and Measures (Intoxicating Liquor) (Amendment) Regulations 2021

3.—(1) The Conformity Assessment (Mutual Recognition Agreements) and Weights and Measures (Intoxicating Liquor) (Amendment) Regulations 2021⁽²⁾ are amended in accordance with paragraph (2).

(2) In Schedule 1 (specified Regulations), after paragraph 3 insert—

(1) 2021 c. 10. See section 5(1) of the Trade Act 2021 for the definition of “appropriate authority”.

(2) S.I. 2021/730.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Conformity Assessment (Mutual Recognition Agreements) and Weights and Measures (Intoxicating Liquor) (Amendment) Regulations 2021 (S.I. 2021/730) (“the 2021 Regulations”) to include Regulation (EU) No 305/2011 of the European Parliament and of the Council of 9 March 2011 laying down harmonised conditions for the marketing of construction products and repealing Council Directive 89/106/EEC (EUR 2011/305) in Schedule 1, making it a specified Regulation for the purposes of the 2021 Regulations.

This amendment is required in relation to the Protocol on the mutual acceptance of the results of conformity assessment to the Agreement on Trade Continuity between the United Kingdom of Great Britain and Northern Ireland and Canada (“the Agreement”) which requires the United Kingdom to accept conformity assessment procedures performed and conformity assessment results issued by a Canadian designated conformity assessment body in respect of construction products.
