The Secretary of State makes these Regulations in exercise of the powers conferred by sections 182 and 183(1) of the Health and Care Act 2022⁽¹⁾.

PART 1

Introductory

Citation, commencement and extent

1.—(1) These Regulations may be cited as the Health and Care Act 2022 (Further Consequential Amendments) (No. 2) Regulations 2023 and come into force on 6th November 2023.

(2) Any amendment or revocation made by the provisions in Parts 2 and 3 has the same extent as the provision amended or revoked.

PART 2

Provisions relating to the National Health Service

Part 2 makes amendments which are consequential on the National Health Service Commissioning Board being renamed to NHS England (see section 1 of the 2022 Act).

Part 3 makes amendments which are consequential on the establishment of integrated care boards and the abolition of clinical commissioning groups (see section 19 of the 2022 Act).
