# 2012 No. 1261

## The Velindre National Health Service Trust Shared Services Committee (Wales) Regulations 2012

### PART 1

#### Introduction

##### Title and commencement

1. The title of these Regulations is the Velindre National Health Service Trust Shared Services Committee (Wales) Regulations 2012 and they come into force on 1 June 2012.

##### Interpretation

2. In these Regulations—

“the Act” (“*y Ddeddf*”) means the National Health Service (Wales) Act 2006;

“chief officers” (“*prif swyddogion*”) means the chief officer of each Local Health Board and National Health Service Trust<sup>[F1]</sup>, and the chief officer or chief executive of each Special Health Authority established by the Welsh Ministers under section 22 of the Act;

“executive director” (“*cyfarwyddwr gweithredol*”) means, in accordance with paragraph 3 of Schedule 3 to the Act, a director who is an employee of the National Health Service Trust;

“health service body” (“*corff gwasanaeth iechyd*”) means <sup>[F2]</sup>a clinical commissioning group, <sup>[F3]</sup>NHS England, the National Institute for Health and Care Excellence, <sup>[F4]</sup>Health Education England, the Health Research Authority, the Health and Social Care Information Centre, a Special Health Authority; a Strategic Health Authority; a Local Health Board; an NHS Trust; an NHS Foundation Trust or a Primary Care Trust;

“Local Health Board” (“*Bwrdd Iechyd Lleol*”) means a Local Health Board established in accordance with section 11(2) of the Act<sup>M1</sup>;

“member” (“*aelod*”) means a member of the committee as set out in regulation 5;

“National Health Service Trust” (“*Ymddiriedolaeth Gwasanaeth Iechyd Gwladol*”) means a National Health Service Trust established in accordance with section 18(1) of the Act<sup>M2</sup>;

“nominated representative” (“*cynrychiolydd enwebedig*”) means, in relation to a chief officer of a Local Health Board, an officer member of his or her Local Health Board and, in relation to a chief officer of a National Health Service Trust, an executive director of his or her National Health Service Trust <sup>[F5]</sup>and, in relation to a chief officer of a Special Health Authority, an officer member of the chief officer’s Special Health Authority;

“officer member” (“*swyddog-aelod*”) means a member of a Local Health Board that holds any office set out in regulation 3(2) of the Local Health Boards (Constitution, Membership and Procedures) (Wales) Regulations 2009;

“shared services” (“*cydwasanaethau*”) means administrative, professional and technical services provided to the health service in Wales;

“the committee” (“*y pwyllgor*”) means the Velindre National Health Service Trust Shared Services Committee established by these Regulations;

“Velindre National Health Service Trust” (“*Ymddiriedolaeth Gwasanaeth Iechyd Gwladol Felindre*”) means Velindre National Health Service Trust established by the Velindre National Health Service Trust (Establishment) Order 1993 <sup>M3</sup>.
