The County Court (Amendment) Rules (Northern Ireland) 2022

Made--20th September 2022Coming into operation -3rd October 2022

The County Court Rules Committee makes and the Department of Justice, after consultation with the Lady Chief Justice, allows the following Rules in exercise of the powers conferred by Article 47 of the County Courts (Northern Ireland) Order 1980(1).

Citation and Commencement

1. These Rules may be cited as the County Court (Amendment) Rules (Northern Ireland) 2022 and shall come into operation on 3rd October 2022.
