The Lomond and Argyll Primary Care National Health Service Trust (Establishment) Amendment Order 1999

Made - - - - 29th September 1999

Coming into force - - 1st October 1999

The Scottish Ministers, in exercise of the powers conferred on them by section 12A(1) and (4) of, and paragraphs 1 and 3(1)(b) and (c) of Schedule 7A to, the National Health Service (Scotland) Act 1978(1) and of all other powers enabling them in that behalf, hereby make the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Lomond and Argyll Primary Care National Health Service Trust (Establishment) Amendment Order 1999 and shall come into force on 1st October 1999.

In this Order—

“the principal Order” means the Lomond and Argyll Primary Care National Health Service Trust (Establishment) Order 1998(2);

“the trust’s area of responsibility” means that part of Argyll and Clyde Health Board’s area which lies to the north of the River Clyde.

Amendment of the principal Order

2.—(1) For article 3 of the principal Order there is substituted—

“Nature and functions of the trust

3.—(1) The trust is established for the purpose specified in section 12A(1) of the Act.

(2) The trust’s functions shall be—

(a) to provide goods and services for the purpose of the Health Service at, from or through hospital accommodation and facilities at Argyll and Bute Hospital,

The functions of the Secretary of State were transferred to the Scottish Ministers by virtue of section 53 of the Scotland Act 1998 (c. 46).

Lochgilthead, and at establishments associated with that hospital, and also including the management of any teaching and research facilities associated with those establishments and the support services related thereto;

- (b) insofar as not included in paragraph (a) above, to make arrangements for the provision of services mentioned in Part II of the Act in respect of the trust's area of responsibility; and
- (c) to carry out the primary and community health care functions of Argyll and Clyde Health Board under the following Regulations—
 - (i) The National Health Service (Dental Charges) (Scotland) Regulations 1989(3);
 - (ii) The National Health Service (Optical Charges and Payments) (Scotland) Regulations 1998(4);
 - (iii) The National Health Service (Charges for Drugs and Appliances) (Scotland) Regulations 1989(5);
 - (iv) The National Health Service (Travelling Expenses and Remission of Charges) (Scotland) Regulations 1988(6).”

(2) In article 4 of the principal Order (directors of the trust) for the words “non executive directors” there is substituted “trustees”.
