The Scottish Parliament (Disqualification) Order 2015

Coming into force		9th October 2015

At the Court at Buckingham Palace, the 8th day of October 2015

Present, The Queen's Most Excellent Majesty in Council

This Order is made in exercise of the powers conferred by section 15(1) and (2) of the Scotland Act 1998(1) and all other powers enabling Her Majesty to do so.

In accordance with section 115(1) of, and paragraphs 1 and 2 of Schedule 7 to, that Act a draft of this Order was laid before and approved by resolution of the Scottish Parliament(2).

Accordingly, Her Majesty is pleased, by and with the advice of Her Privy Council, to order as follows:

Citation and commencement

1. This Order may be cited as the Scottish Parliament (Disqualification) Order 2015 and comes into force on the day after the day on which it is made.

Specified office-holders

2. An office-holder of a description specified in Part 1 of the Schedule is disqualified from being a member of the Scottish Parliament.

3. An office-holder of a description specified in column 1 of Part 2 of the Schedule is disqualified from being a member of the Scottish Parliament for any constituency specified in relation to that
