# **1981 CHAPTER 61**

An Act to make fresh provision about citizenship and nationality, and to amend the Immigration Act 1971 as regards the right of abode in the United Kingdom. [30th October 1981]

# BRITISH CITIZENSHIP

# Acquisition after commencement

# **1** Acquisition by birth or adoption.

- (1) A person born in the United Kingdom after commencement [<sup>F1</sup>, or in a qualifying territory on or after the appointed day,] shall be a British citizen if at the time of the birth his father or mother is—
  - (a) a British citizen; or
  - (b) settled in the United Kingdom [<sup>F2</sup>or that territory].
- [<sup>F3</sup>(1A) A person born in the United Kingdom or a qualifying territory on or after the relevant day shall be a British citizen if at the time of the birth his father or mother is a member of the armed forces.]
  - (2) A new-born infant who, after commencement, is found abandoned in the United Kingdom [<sup>F4</sup>, or on or after the appointed day is found abandoned in a qualifying territory,] shall, unless the contrary is shown, be deemed for the purposes of subsection (1)—
    - (a) to have been born in the United Kingdom after commencement [<sup>F5</sup>or in that territory on or after the appointed day]; and
    - (b) to have been born to a parent who at the time of the birth was a British citizen or settled in the United Kingdom [<sup>F6</sup>or that territory].
  - (3) A person born in the United Kingdom after commencement who is not a British citizen by virtue of subsection (1) [<sup>F7</sup>, (1A)] or (2) [<sup>F8</sup>or section 10A] shall be entitled to be registered as a British citizen if, while he is a minor—
    - (a) his father or mother becomes a British citizen or becomes settled in the United Kingdom; and
    - (b) an application is made for his registration as a British citizen.
- [<sup>F9</sup>(3A) A person born in the United Kingdom on or after the relevant day who is not a British citizen by virtue of subsection (1), (1A) or (2) [<sup>F10</sup>or section 10A] shall be entitled to be registered as a British citizen if, while he is a minor—
  - (a) his father or mother becomes a member of the armed forces; and
  - (b) an application is made for his registration as a British citizen]
  - (4) A person born in the United Kingdom after commencement who is not a British citizen by virtue of subsection (1) [<sup>F11</sup>, (1A)] or (2) [<sup>F12</sup>or section 10A] shall be entitled, on an application for his registration as a British citizen made at any time after he has attained the age of ten years, to be registered as such a citizen if, as regards each of the first ten years of that person's life, the number of days on which he was absent from the United Kingdom in that year does not exceed 90.
- [<sup>F13</sup>(5) Where—
  - (a) any court in the United Kingdom [<sup>F14</sup>or, on or after the appointed day, any court in a qualifying territory] makes an order authorising the adoption of a minor who is not a British citizen; or

(b) a minor who is not a British citizen is adopted under a Convention adoption [<sup>F15</sup>effected under the law of a country or territory outside the United Kingdom],

that minor shall, if the requirements of subsection (5A) are met, be a British citizen as from the date on which the order is made or the Convention adoption is effected, as the case may be.

- (5A) Those requirements are that on the date on which the order is made or the Convention adoption is effected (as the case may be)—
  - (a) the adopter or, in the case of a joint adoption, one of the adopters is a British citizen; and
  - (b) in a case within subsection (5)(b), the adopter or, in the case of a joint adoption, both of the adopters are habitually resident in the United Kingdom [<sup>F16</sup>or in a designated territory].]
  - (6) Where an order [<sup>F17</sup>or a Convention adoption] in consequence of which any person became a British citizen by virtue of subsection (5) ceases to have effect, whether on annulment or otherwise, the cesser shall not affect the status of that person as a British citizen.
  - (7) If in the special circumstances of any particular case the Secretary of State thinks fit, he may for the purposes of subsection (4) treat the person to whom the application relates as fulfilling the requirement specified in that subsection although, as regards any one or more of the first ten years of that person's life, the number of days on which he was absent from the United Kingdom in that year or each of the years in question exceeds 90.
  - (8) In this section and elsewhere in this Act "settled" has the meaning given by section 50

# 2 Acquisition by descent.

- (1) A person born outside the United Kingdom [<sup>F20</sup> and the qualifying territories] after commencement shall be a British citizen if at the time of the birth his father or mother—
  - (a) is a British citizen otherwise than by descent; or
  - (b) is a British citizen and is serving outside the United Kingdom [<sup>F21</sup>and the qualifying territories] in service to which this paragraph applies, his or her recruitment for that service having taken place in the United Kingdom [<sup>F22</sup>or a qualifying territory]; or
  - (c) is a British citizen and is serving outside the United Kingdom [<sup>F23</sup>and the qualifying territories] in service under an [<sup>F24</sup>EU] institution, his or her recruitment for that service having taken place in a country which at the time of the recruitment was a member of [<sup>F25</sup>the European Union].
- (2) Paragraph (b) of subsection (1) applies to—
  - (a) Crown service under the government of the United Kingdom [<sup>F26</sup>or of a qualifying territory]; and
  - (b) service of any description for the time being designated under subsection (3).

  - (3) For the purposes of this section the Secretary of State may by order made by statutory instrument designate any description of service which he considers to be closely associated with the activities outside the United Kingdom [<sup>F27</sup>and the qualifying territories] of Her Majesty's government in the United Kingdom [<sup>F28</sup>or in a qualifying territory].
  - (4) Any order made under subsection (3) shall be subject to annulment in pursuance of a resolution of either House of Parliament.

## **3** Acquisition by registration: minors.

- (1) If while a person is a minor an application is made for his registration as a British citizen, the Secretary of State may, if he thinks fit, cause him to be registered as such a citizen.
- (2) A person born outside the United Kingdom [<sup>F29</sup> and the qualifying territories] shall be entitled, on an application for his registration as a British citizen made [<sup>F30</sup>while he is a minor], to be registered as such a citizen if the requirements specified in subsection (3) or, in the case of a person born stateless, the requirements specified in paragraphs (a) and (b) of that subsection, are fulfilled in the case of either that person's father or his mother ("the parent in question").
- (3) The requirements referred to in subsection (2) are—
  - (a) that the parent in question was a British citizen by descent at the time of the birth; and
  - (b) that the father or mother of the parent in question—
    - (i) was a British citizen otherwise than by descent at the time of the birth of the parent in question; or

- (ii) became a British citizen otherwise than by descent at commencement, or would have become such a citizen otherwise than by descent at commencement but for his or her death; and
- (c) that, as regards some period of three years ending with a date not later than the date of the birth—
  - (i) the parent in question was in the United Kingdom [<sup>F31</sup>or a qualifying territory] at the beginning of that period; and
  - (ii) the number of days on which the parent in question was absent from the United Kingdom [<sup>F32</sup>and the qualifying territories] in that period does not exceed 270.
- (5) A person born outside the United Kingdom [<sup>F34</sup>and the qualifying territories] shall be entitled, on an application for his registration as a British citizen made while he is a minor, to be registered as such a citizen if the following requirements are satisfied, namely—
  - (a) that at the time of that person's birth his father or mother was a British citizen by descent; and
  - (b) subject to subsection (6), that that person and his father and mother were in the United Kingdom [<sup>F35</sup> or a qualifying territory] at the beginning of the period of three years ending with the date of the application and that, in the case of each of them, the number of days on which the person in question was absent from the United Kingdom [<sup>F36</sup> and the qualifying territories] in that period does not exceed 270; and
  - (c) subject to subsection (6), that the consent of his father and mother to the registration has been signified in the prescribed manner.
- (6) In the case of an application under subsection (5) for the registration of a person as a British citizen—
  - (a) if his father or mother died, or their marriage [<sup>F37</sup>or civil partnership] was terminated, on or before the date of the application, or his father and mother were legally separated on that date, the references to his father and mother in paragraph (b) of that subsection shall be read either as references to his father or as references to his mother; [<sup>F38</sup> and]
  - (b) if his father or mother died on or before that date, the reference to his father and mother in paragraph (c) of that subsection shall be read as a reference to either of them; <sup>F39</sup>...

# 4 Acquisition by registration: [<sup>F42</sup>British overseas territories citizens]etc.

- (1) This section applies to any person who is a [<sup>F43</sup>British overseas territories citizen], [<sup>F44</sup>a British National (Overseas),] a British Overseas citizen, a British subject under this Act or a British protected person.
- (2) A person to whom this section applies shall be entitled, on an application for his registration as a British citizen, to be registered as such a citizen if the following requirements are satisfied in the case of that person, namely—
  - (a) subject to subsection (3), that he was in the United Kingdom at the beginning of the period of five years ending with the date of the application and that the number of days on which he was absent from the United Kingdom in that period does not exceed 450; and
  - (b) that the number of days on which he was absent from the United Kingdom in the period of twelve months so ending does not exceed 90; and
  - (c) that he was not at any time in the period of twelve months so ending subject under the immigration laws to any restriction on the period for which he might remain in the United Kingdom; and

- (d) that he was not at any time in the period of five years so ending in the United Kingdom in breach of the immigration laws.
- (3) So much of subsection (2)(a) as requires the person in question to have been in the United Kingdom at the beginning of the period there mentioned shall not apply in relation to a person who was settled in the United Kingdom immediately before commencement.
- (4) If in the special circumstances of any particular case the Secretary of State thinks fit, he may for the purposes of subsection (2) do all or any of the following things, namely—
  - [<sup>F45</sup>(za) treat the person to whom the application relates as fulfilling the first requirement specified in subsection (2)(a) although the person was not in the United Kingdom at the beginning of the period there mentioned;]
    - (a) treat the person to whom the application relates as fulfilling the [<sup>F46</sup>second requirement specified in subsection (2)(a) or the requirement specified in] subsection (2)(b), or both, although the number of days on which he was absent from the United Kingdom in the period there mentioned exceeds the number there mentioned;
    - (b) disregard any such restriction as is mentioned in subsection (2)(c), not being a restriction to which that person was subject on the date of the application;
    - (c) treat that person as fulfilling the requirement specified in subsection (2)(d) although he was in the United Kingdom in breach of the immigration laws in the period there mentioned.
- [<sup>F47</sup>(4A) Subsection (4B) applies where, on an application for registration as a British citizen made by a person to whom this section applies, the applicant has indefinite leave to enter or remain in the United Kingdom.
  - (4B) The Secretary of State may for the purposes of subsection (2) treat the applicant as fulfilling the requirement specified in subsection (2)(d), without enquiring into whether or not the applicant was in the United Kingdom in breach of the immigration laws in the period there mentioned.

- (1) If an application is made for a person of full age and capacity ("P") to be registered as a British citizen, the Secretary of State may cause P to be registered as such a citizen if, in the Secretary of State's opinion, P would have been, or would have been able to become, a British citizen but for—
  - (a) historical legislative unfairness,
  - (b) an act or omission of a public authority, or
  - (c) exceptional circumstances relating to P.

# 12 Renunciation.

- (b) on the date on which the adoption is effected—

# 16 Acquisition by descent.

- (1) A person born outside the [<sup>F98</sup>British overseas territories] after commencement shall be a [<sup>F99</sup>British overseas territories citizen] if at the time of the birth his father or mother—

# 17 Acquisition by registration: minors.

- If while a person is a minor an application is made for his registration as a [<sup>F102</sup>British overseas territories citizen] the Secretary of State may, if the thinks fit, cause him to be registered as such a citizen.

# [<sup>F112</sup>17A Registration: remedying inability of mothers to transmit citizenship

- (b) P would have been a citizen of the United Kingdom and Colonies immediately before commencement had P's parents been treated equally, for the purposes of determining P's nationality status, by any independence legislation that caused P to lose that citizenship.
- (3) In subsection (2)—

"relevant previous provision" means a provision of the law that was in force at some time before 1 January 1949 which provided for a nationality status to be transmitted from a parent to a child without the need for an application to be made for the child to be registered as a person with that nationality status;

"independence legislation" means an Act of Parliament or any subordinate legislation (within the meaning of the Interpretation Act 1978) forming part of the law in the United Kingdom (whenever passed or made, and whether or not still in force)—

- (a) providing for a country or territory to become independent from the United Kingdom, or
- (b) dealing with nationality, or any other ancillary matters, in connection with a country or territory becoming independent from the United Kingdom.
- (4) In determining for the purposes of subsection (2) whether a person would have become a citizen of the United Kingdom and Colonies under section 5 of the British Nationality Act 1948, the requirement that a person's birth was registered at a United Kingdom consulate, as set out in subsection (1)(b) of that section, is to be ignored.

    - (i) at birth, or
    - (ii) by virtue of paragraph 3 of Schedule 3 to the British Nationality Act 1948 (child of male British subject to become citizen of the United Kingdom and Colonies if father becomes such a citizen).
- (5) A person who is registered as a British overseas territories citizen under this section is a British overseas territories citizen by descent if the citizenship which the person would have acquired at commencement (as mentioned in subsection (1)(c)(ii)) would (by virtue of section 25) have been citizenship by descent.

- (h) he is a [<sup>F135</sup>British overseas territories citizen] by virtue of registration under section 13 (as applied by section 24) who, immediately before he ceased to be a [<sup>F135</sup>British overseas territories citizen] as a result of a declaration of renunciation, was such a citizen by descent; or
- (i) he is a person born in the United Kingdom after commencement who is a [<sup>F135</sup>British overseas territories citizen] by virtue of paragraph 1 of Schedule 2.
- (2) A person born outside the [<sup>F136</sup>British overseas territories] before commencement is not a [<sup>F135</sup>British overseas territories citizen]"by descent" by virtue of subsection (1) (b), (d), (e) or (f) if his father was at the time of his birth serving outside the [<sup>F136</sup>British overseas territories] in service of a description mentioned in subsection (3), his recruitment for the service in question having taken place in a [<sup>F139</sup>British overseas territory].

## 43 Exercise of functions of Secretary of State by Governors and others.

## 46 Offences and proceedings.

- (1) Any person who for the purpose of procuring anything to be done or not to be done under this Act—

# 52 Consequential amendments, transitional provisions, repeals and savings.

# *Naturalisation as a British citizen under section* 6(1)





# TRANSITIONAL PROVISIONS

Applications for naturalisation or registration pending at commencement

- 1 (1) This paragraph applies to any application—
  - (a) for registration under any provision of the British Nationality Acts 1948 to 1965 as a citizen of the United Kingdom and Colonies or as a British subject; or
  - (b) for a certificate of naturalisation under section 10 of the 1948 Act,

which is received before commencement by a person authorised to receive it on behalf of the person to whom it is made but which at commencement has not been determined.

(2) In relation to any application to which this paragraph applies—

- (a) the British Nationality Acts 1948 to 1965 and all regulations and arrangements in force under them immediately before commencement shall (so far as applicable) continue to apply; and
- (b) this Act shall not apply;

but on the granting of such an application and the taking under those Acts of such other steps as are necessary for the person in question to become—

(i) a citizen of the United Kingdom and Colonies by virtue of any provision of those Acts; or

(ii) a British subject by virtue of registration under any provision of those Acts,

that person, instead of becoming a citizen or subject of that description, shall become under this Act such a citizen or subject as he would have become at commencement if, immediately before commencement, he had been such a citizen or subject as is mentioned in paragraph (i) or (ii), as the case may be.

- (3) Sub-paragraph (2) shall have effect as if the references in it to the British Nationality Acts 1948 to 1965 did, and as if the reference in paragraph (b) of it to this Act did not, include section 49 of this Act.
- Where a person who has been registered or to whom a certificate of naturalisation has been granted before the passing of this Act has at commencement not yet taken the oath of allegiance, paragraph 1(2) shall apply as if the application on which he was registered or the certificate was granted were an application to which paragraph 1 applies.

Registration at U.K. consulate, after commencement, of certain births occurring in foreign countries less than a year before commencement

- 3 (1) This paragraph applies to a person born less than a year before commencement if—
  - (a) the birth occurred in a place in a foreign country (within the meaning of the 1948 Act); and
  - at the time of the birth his father was a citizen of the United Kingdom and (b) Colonies by descent only; and
  - the birth was not registered at a United Kingdom consulate before (c) commencement.
  - (2) If the birth of a person to whom this paragraph applies is registered at a United Kingdom consulate within one year of its occurrence, he shall be deemed for the purposes of this Act to have been, immediately before commencement, a citizen of the United Kingdom and Colonies by virtue of section 5 of the 1948 Act (citizenship by descent).
  - (3) References in this paragraph to the 1948 Act are references to that Act as in force at the time of the birth in question.

Declarations by certain persons who by virtue of an Order in Council under section 4 of the Cyprus Act 1960 have ceased to be citizens of the United Kingdom and Colonies

- 4 (1) Where
  - a person has before commencement duly made a declaration under (a) section 4(2) of the <sup>M37</sup>Cyprus Act 1960 of his intention to resume citizenship of the United Kingdom and Colonies; but
  - (b) at commencement the declaration has not been registered,

the Secretary of State shall cause the declaration to be registered.

- (2) If
  - a person who in consequence of anything done before he attained the age of (a) sixteen years ceased by virtue of an Order in Council under section 4 of the Cyprus Act 1960 to be a citizen of the United Kingdom and Colonies makes, in such a manner as the Secretary of State may direct, a declaration of his intention to accept the citizenship available to him under this paragraph; and
  - the declaration is made by him after commencement and within one year (b) after his attaining the age of twenty-one years,

the Secretary of State shall cause the declaration to be registered.

(3) On the registration under sub-paragraph (1) or (2) of any such declaration as is there mentioned the person who made it shall become under this Act such a citizen as he would have become at commencement if, immediately before commencement, he had been a citizen of the United Kingdom and Colonies by virtue of section 4(2) of the Cyprus Act 1960.
