## 88 Construction and application of Part VI.

- (1) In this Part—
  - (a) expressions which are used in Part XIII of the MI Housing Act 1985 (general financial provisions) have the same meaning as in that Part;
  - [F1(aa) "the appropriate person" means—
    - (i) in relation to England, the Secretary of State, and
    - (ii) in relation to Wales, | F<sup>2</sup>Welsh Ministers|;
    - (b) references to a local housing authority's Housing Revenue Account or Housing Repairs Account include, where the context so admits, references to the corresponding account kept by them under that Part;
    - (c) references to a revenue account of a local housing authority other than their Housing Revenue Account do not include references to a Housing Repairs Account; [F3 and]
    - (d) references to proper practices shall be construed in accordance with [F4section 21 of the Local Government Act 2003][F5; and
    - "electronic communication" means a communication transmitted (whether from one person to another, from one device to another or from a person to a device or vice versa)—
      - <sup>F7</sup>(i) by means of [F8 an electronic communications network]; or
      - (ii) by other means but while in an electronic form;
    - <sup>F9</sup>(f) "address", in relation to electronic communications, includes any number or address used for the purposes of such communications.]
