SUGAR

**The Sugar Act 1956 (Repeals)
(Appointed Day) (No. 1) Order 1973**

Made - - - - - *31st January 1973*
Coming into Operation *1st February 1973*

The Minister of Agriculture, Fisheries and Food and the Secretary of State acting jointly in exercise of the powers conferred upon them by section 4 of, and part II of Schedule 3 to, the European Communities Act 1972, and of all other powers enabling them in that behalf, hereby make the following order:—

1.—(1) This order may be cited as the Sugar Act 1956 (Repeals) (Appointed Day) (No. 1) Order 1973, and shall come into operation on 1st February 1973.

(2) The Interpretation Act 1889 shall apply to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

2. The repeal of the enactments mentioned in the Schedule to this order shall take effect, to the extent specified in column 3 of the Schedule, on 1st February 1973.
