The Child Abduction and Custody (Parties to Conventions) Order 1989

Made - - - 15th March 1989

At the Court at Buckingham Palace, the 15th day of March 1989 Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 2 of the Child Abduction and Custody Act 1985(1), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1.—(1) This Order may be cited as the Child Abduction and Custody (Parties to Conventions) Order 1989.
- (2) The Child Abduction and Custody (Parties to Conventions) (Amendment) (No. 3) Order 1988(2) is revoked.
- **2.** The Child Abduction and Custody (Parties to Conventions) Order 1986(3) is amended by deleting Schedule 1 thereto(4) and substituting therefor the following –
