**The Civil Proceedings Fees (Amendment)  
(No.2) (Amendment) Order 2007**

The Lord Chancellor makes the following Order in exercise of the powers conferred by section 92 of the Courts Act 2003<sup>(1)</sup>.

In accordance with section 92(1) of the Courts Act 2003 he has obtained the consent of the Treasury. In accordance with section 92(5) and (6) of the Courts Act 2003 he has consulted the Lord Chief Justice, the Master of the Rolls, the President of the Queen's Bench Division, the President of the Family Division, the Chancellor of the High Court, the Head of Civil Justice, the Deputy Head of Civil Justice and the Civil Justice Council.

**1.** This Order may be cited as the Civil Proceedings Fees (Amendment) (No.2) (Amendment) Order 2007 and shall come into force on 28th September 2007.

**2.—(1)** Schedule 1 in the Schedule to the Civil Proceedings Fees (Amendment) (No. 2) Order 2007<sup>(2)</sup>, is amended as follows.

(2) In column 2—

- (a) in fee 1.1(c), for “£60” substitute “£65”;
- (b) in fee 1.1(d), for “£70” substitute “£75”;
- (c) in fee 1.1(e), for “£80” substitute “£85”;
- (d) in fee 1.3(c), for “£65” substitute “£60”;

- (4) Omit fee 10.6.
