**The Agriculture (Calculation of Value for Compensation)  
(Revocations) (England) Regulations 2015**

The Secretary of State makes the following regulations in exercise of the powers conferred by section 66(2) of the Agricultural Holdings Act 1986(1).

**Citation, commencement and application**

1. These Regulations—
  - (a) may be cited as the Agriculture (Calculation of Value for Compensation) (Revocations) (England) Regulations 2015;
  - (b) come into force on 1st October 2015; and
  - (c) apply in relation to England only.
2. The following regulations are revoked—
  - (a) the Agriculture (Calculation of Value for Compensation) Regulations 1978(2);
  - (b) the Agriculture (Calculation of Value for Compensation) (Amendment) Regulations 1980(3);
  - (c) the Agriculture (Calculation of Value for Compensation) (Amendment) Regulations 1981(4); and
  - (d) the Agriculture (Calculation of Value for Compensation) (Amendment) Regulations 1983(5).
