**The National Health Service Trusts
(Wales) (Dissolution No. 2) Order 1999**

Made - - - - *15th December 1999*

Coming into force - - *1st April 2000*

The National Assembly for Wales makes the following Order in exercise of the powers conferred on the Secretary of State for Wales by Section 126(3) of the National Health Service Act 1977⁽¹⁾ and section 5(1), and paragraph 29(1) of Schedule 2 to the National Health Service and Community Care Act 1990⁽²⁾ and of all other powers enabling the Secretary of State in that behalf and now vested in the National Assembly for Wales⁽³⁾, considering it appropriate in the interests of the health service to make this Order⁽⁴⁾, and after completion of the consultation prescribed under paragraph 29(3) of Schedule 2 to the latter Act⁽⁵⁾:

Citation and commencement

1. This Order may be cited as the National Health Service Trusts (Wales) (Dissolution No. 2) Order 1999 and shall come into force on 1st April 2000.

Dissolution of NHS Trusts

2.—(1) The University Hospital of Wales and Llandough Hospital National Health Service Trust and the Cardiff and District Community National Health Service Trust are hereby dissolved.

(2) The Orders specified in column (1) of the Schedule to this Order are hereby revoked.
