COMMISSION DECISION

of 1 March 1976

on the sale of skimmed-milk powder from public stocks to certain international organizations for supply to developing countries

THE COMMISSION OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products (1), as last amended by Regulation (EEC) No 740/75 (2), and in particular Article 7 (5) thereof,

Whereas Council Regulation (EEC) No 155/75 of 21 January 1975 (3), as amended by Regulation (EEC) No 1960/75 (4), provides for the sale of skimmed-milk powder from public stocks for supply to developing countries:

Whereas the international organizations, World Food Programme (WFP) and Caritas, mentioned in Article 2 of Commission Regulation (EEC) No 602/75 of 7 March 1975 laying down detailed rules for the sale of skimmed-milk powder in public storage for supply to developing countries (5), as last amended by Regulation (EEC) No 3193/75 (6), have submitted applications to the Commission for 1504 metric tons of skimmed-milk powder for supply to certain third countries; whereas these applications should be granted and the Dutch and Belgian intervention agencies should be authorized to supply the quantities requested;

Whereas the international organizations in question should be exempted under Article 5 (2) of Regulation (EEC) No 602/75 from having to provide the security referred to in Article 8 (2) of that Regulation; whereas, on account of the small quantity Caritas has requested, this organization should also be exempted from having to provide prior to purchase the undertaking referred to in Article 7 of Regulation (EEC) No 602/75;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS DECISION:

Article 1

- The Dutch and Belgian intervention agencies are hereby authorized to sell skimmed-milk powder in accordance with the provisions laid down in Regulation (EEC) No 602/75 and under the conditions fixed in the Annex.
- By way of derogation from Article 8 (2) of Regulation (EEC) No 602/75, the international organizations in question shall not be required to provide security prior to taking delivery of the quantities of skimmed-milk powder indicated in the Annex.
- By way of derogation from the first indent of Article 6 (c) of Regulation (EEC) No 602/75, the conclusion of the selling contract for skimmed-milk powder bought-in by the international organization Caritas shall not be subject to the presentation of the certificate referred to in Article 7 of the said Regulation.

Article 2

This Decision is addressed to the Kingdom of the Netherlands and to the Kingdom of Belgium.
