COUNCIL DECISION

of 29 June 1976

amending in respect of Romania certain quotas for imports into the Benelux countries and into Ireland laid down by Decision 75/788/EEC

(76/615/EEC)

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 113 thereof,

Having regard to Council Decision 75/210/EEC of 27 March 1975 on unilateral import arrangements in respect of State-trading countries⁽¹⁾, and in particular the first indent of Article 7 thereof,

Having regard to the proposal from the Commission, Whereas, in accordance with Article 3 of the said Decision, the Belgian Government, on behalf of the three Benelux countries, and the Irish Government consider that amendments should be made to certain of the quotas for imports into the Benelux countries and into Ireland laid down by Council Decision 75/788/EEC of 18 December 1975 amending for 1976 the import quotas laid down by Decision 75/210/EEC⁽²⁾;

Whereas the amendments proposed refer to some of the import quotas laid down in respect of Romania for products covered by the Arrangement regarding international trade in textiles⁽³⁾;

Whereas on 15 March 1975 the Council authorized Community negotiations to be opened with Romania in respect of textile products covered by this Arrangement; whereas, therefore, amendments to the import quotas concerned can be adopted only by means of a Council Decision under Article 113 of the Treaty;

Whereas the amendments proposed are not such as to hinder the progressive standardization of the import

arrangements applied in the Member States, nor to affect the proper functioning of the common market; whereas, therefore the measures proposed by the Benelux countries and Ireland should be adopted,

HAS ADOPTED THIS DECISION:

Article 1

The values of those quotas for imports into the Benelux countries, given in Annex VI (a) to Decision 75/788/EEC which are set out in Annex I hereto, are replaced by the values shown in the latter Annex.

Article 2

Annex VI (e) (Ireland) to Decision 75/788/EEC is hereby replaced by the Annex given in Annex II hereto.

Article 3

This Decision is addressed to the Benelux countries and Ireland.
