## THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Directive 72/462/EEC of 12 December 1972 on health and veterinary inspection problems upon importation of bovine, ovine and caprine animals and swine, fresh meat or meat products from third countries<sup>(1)</sup>, and in particular Article 11(2) thereof,

Having regard to Council Directive 91/68/EEC of 28 January 1991 on animal health conditions governing intra-Community trade in ovine and caprine animals<sup>(2)</sup>, and in particular Article 14(2) thereof,

## Whereas:

- (1) The model of veterinary certificate for intra-Community trade in ovine and caprine animals for breeding is laid down as model III of Annex E to Directive 91/68/EEC.
- (2) The model of veterinary certificate for imports of domestic ovine and caprine animals from third countries is laid down as 'OVI-X' in part 2 of Annex I to Council Decision 79/542/EEC of 21 December 1976 drawing up a list of third countries or parts of third countries, and laying down animal and public health and veterinary certification conditions, for importation into the Community of certain live animals and their fresh meat<sup>(3)</sup>.
- (3) In accordance with part I of Chapter A of Annex VIII and Chapter E of Annex IX to Regulation (EC) No 999/2001 of the European Parliament and of the Council of 22 May 2001 laying down rules for the prevention, control and eradication of certain transmissible spongiform encephalopathies<sup>(4)</sup>, certain requirements on trade in and imports of ovine and caprine animals for breeding have been changed in order to reflect a more vigorous approach as regards scrapie eradication.

- (4)It is necessary to align the animal health certificate model III in Annex E to Directive 91/68/EEC and the model certificate OVI-X in Annex I to Decision 79/542/EEC with the updated rules.
- (5) Directive 91/68/EEC and Decision 79/542/EEC should therefore be amended accordingly.
- The measures provided for in this Decision are in accordance with the opinion of the (6)Standing Committee on the Food Chain and Animal Health,

I, the undersigned official veterinarian, hereby certify, that the animals described above meet the following requirements:

- 12.1. they have been inspected today (within 24 hours prior to loading) and show no clinical sign of disease;
- 12.2. they are not animals which are to be destroyed under a scheme to eradicate a contagious or infectious disease;
- 12.3. they were not obtained from a holding which is the subject of a prohibition on animal health grounds and they have not been in contact with animals from such a holding, it being understood that:
- 12.3.1. such prohibition is connected with the outbreak of one of the following diseases to which the animals are susceptible:
  - brucellosis.
  - rabies,
  - anthrax:

- 12.3.4 they are not the subject of animal health measures pursuant to Community legislation on foot-and-mouth disease nor have they been vaccinated against foot-and-mouth disease;
- 12.4. they have remained on a single holding of origin for a period of at least 30 days prior to loading, or since birth in the holding of origin where the animals are less than 30 days old, and no animal of the ovine or caprine species has been introduced into the holding of origin during the last 21 days prior to loading and no biungulate animal imported from a third country has been introduced into the holding of origin during the 30 days prior to dispatch from the holding of origin, unless those animals were introduced in accordance with Article 4a(2) of Directive 91/68/EEC;
- 12.6. they comply with at least one of the following conditions in 12.6.1, 12.6.2 or 12.6.3 and therefore qualify for admission to an ovine or caprine holding which is officially brucellosis-free, (*B. melitensis*) <sup>(4)</sup>:
- 12.6.2. they come from an officially brucellosis-free (B. melitensis) holding (4); or
- 12.6.3. they come from a brucellosis-free (B. melitensis) holding and
  - (i) they are identified individually, and
  - (ii) they have never been vaccinated against brucellosis or if they have been vaccinated were so vaccinated more than two years previously or they are females over two years old which were vaccinated before the age of seven months, and
  - (iii) they were isolated under official supervision on the holding of origin and, during such isolation, underwent, with negative results, two tests for brucellosis in accordance with Annex C to Directive 91/68/EEC, separated by an interval of at least six weeks (4):

- they come from an officially brucellosis -free (B. melitensis) holding (4); or
- they come from a brucellosis-free (B. melitensis) holding (4); or 12.7.2.
- until the qualifying date under eradication plans approved pursuant to Decision 90/242/EEC, they originate from a holding other than that referred to in 12.7.1 and 12.7.2 and satisfy the following conditions: 12.7.3.
  - they are identified individually;
  - they originate from a holding in which all the animals of species susceptible to brucellosis (B. melitensis) have been free of clinical symptoms or any other symptoms of brucellosis for at least 12 months; and
  - (iii) either:
    - they have not been vaccinated against brucellosis (B. melitensis) in the last two years, and
    - they were isolated under veterinary supervision on the holding of origin and, during such isolation, underwent, with negative results, two tests for brucellosis in accordance with Annex C to Directive 91/68/EEC, separated by an interval of at least six weeks <sup>(4)</sup>;

- they were vaccinated with Rev. 1 vaccine before the age of seven months, and
- they were not vaccinated in the 15 days before the date of emission of this health certificate<sup>(4)</sup>;
- 12.8. as regards contagious epididymitis of rams (B. ovis), where uncastrated breeding rams are concerned, they must:
  - come from a holding on which no case of contagious epididymitis of rams (B. ovis) has been recorded in the past 12 months, and

  - have undergone, within 30 days prior to consignment, with a negative result, a test to detect contagious epididymitis of rams (B. ovis) in accordance with Annex D to Directive 91/68/EEC;
- 12.9. to the best of the knowledge of the undersigned and according to the written declaration made by the owner, they were not obtained from a holding nor have been in contact with animals from a holding in which the following diseases have been clinically detected:
  - within the last six months, contagious agalactia of sheep (Mycoplasma agalactiae) and contagious agalactia of goats (Mycoplasma agalactiae, M. capricolum, M. mycoides subsp. mycoides large colony);
  - within the last 12 months, paratuberculosis or caseous lymphadenitis;
  - within the last three years, pulmonary adenomatosis, maedi/visna or caprine viral arthritis/encephalitis. However, this time limit is reduced to 12 months if animals affected by maedi/visna or caprine viral arthritis/encephalitis have been slaughtered and the remaining animals have reacted negatively to two tests;
- 12.10. as regards scrapie, the animals fulfil the requirements provided for in point (a) of part I of Chapter A of Annex VIII to Regulation (EC) No 999/2001;
- 12.10.1. if they are destined for a Member State which benefits, for all or part of its territory, from the provisions laid down in point (b) or (c) of Part I in Chapter A in Annex VIII to Regulation (EC) No 999/2001 they comply with the additional

- (4) The registration number(s) of rail-wagon or lorry and the name of the ship should be given as appropriate. If known, the flight number of the aircraft.
  - In case of transport in containers or boxes, the total number, their registration and seal numbers, if present, should be indicated under point 7.3.
- Keep as appropriate.
- (6) Complete if appropriate.

- (7) The assembly centre must fulfil the conditions for its approval, as laid down in part 3.B of this Annex I.
- (8) The animals must bear:
  - (a) an individual number which permits tracing of their premises of origin. Specify the identification system (i.e. tag, tattoos, brand, chip, transponder) and the anatomic place used in the animal;
  - (b) an ear tag that includes the ISO code of the exporting country

In case of a consignment of more than one animal species, indicate also "ovine" and "caprine" as appropriate.

- (9) Age (months). Sex (M = male, F = female, C = castrated).
- (10) Tests carried out in the animal, when appropriate, before dispatch for exportation. Use, as appropriate, in the following order the codes identifying the diseases tested for in accordance with point (12) Brucellosis (B. melitensis and B. ovis) code "BRL" , point 13 Bluetongue code "BTG"- and Epizootic-haemorrhagic-disease code "EHD"-.
- (11) Only for a territory appearing with the entry "V" in column 6 of Part 1 of Annex I to Council Decision 79/542/EEC (as last amended).
- (12) The representative number of animals to be tested for brucellosis must, for each holding, consist of:
  - all non-castrated male animals, which have not been vaccinated against brucellosis, over six months old,
  - all non-castrated male animals, which have been vaccinated against brucellosis, over 18 months old,
  - all animals brought onto the holding since the previous tests, and
  - 25 % of females which are of reproductive age (sexually mature) or in milk, within a minimum of 50 females.
- (13) This must be completed when the destination is a Member State or part of a Member State laid down in one of the Annexes to Commission Decision 93/52/EEC (as last amended).
- (14) In accordance with Part 3.C of this Annex I.
  - Where more than one holding of origin is involved the date of the most recent test on each holding must be clearly indicated.
- (15) In the case of animals intended, exclusively, for breeding purposes.
- (16) Guarantees in relation to a programme of control of scrapie, as requested by the EU Member State of destination, in application of Article 15 and Annex IX, Chapter E of Regulation (EC) No 999/2001.
- (17) Supplementary guarantees to be provided when required in column 5 "SG" of part 1 of Annex I to Decision 79/542/EEC (as last amended), with the entry "A". Tests for Bluetongue and for Epizootic-haemorrhagic-disease in accordance with Part 3.C of this Annex I.
- (18) Date of loading. Imports of these animals shall not be allowed when the animals were loaded either prior to the date of authorisation for exportation to the European Community of the territory mentioned under (3), or during a period where restrictive measures have been adopted by the European Community against imports of these animals from this territory.'
