## Article 2

## Veterinary checks

1 [<sup>F1</sup>The appropriate authority] shall take the measures necessary to ensure that pet birds moved into [<sup>F2</sup>Great Britain] from a third country are subject to documentary and identity checks by the competent [<sup>F3</sup>authority] at the traveller's point of entry <sup>F4</sup>....

2 [<sup>F5</sup>The appropriate authority] shall designate the [<sup>F6</sup>authority] referred to in paragraph 1 which is responsible for such checks <sup>F7</sup>....

3 [<sup>F8</sup>The appropriate authority] shall draw up a list of points of entry as referred to in paragraph 1 and forward it to [<sup>F9</sup>the other appropriate authorities].
