Directive 98/26/EC of the European Parliament and of the Council of 19 May 1998 on settlement finality in payment and securities settlement systems

## **SECTION I**

## SCOPE AND DEFINITIONS

Article 1

The provisions of this Directive shall apply to:

- (a) any system as defined in Article 2(a), governed by the law of a Member State and operating in any currency, the [Fleuro] or in various currencies which the system converts one against another;
- (b) any participant in such a system;
- (c) collateral security provided in connection with:
  - participation in a system, or
  - [F1operations of the central banks of the Member States or the European Central Bank in the context of their function as central banks.]
