REGULATION (EURATOM) No 227/70 OF THE COUNCIL

of 3 February 1970

amending the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in the Netherlands

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Conditions of Employment of Other Servants of the European Communities, laid down by Regulation (EEC, EURATOM, ECSC) No 259/68,¹ as amended by Regulation (EURATOM, ECSC, EEC) No 2278/69,² and in particular the second paragraph of Article 4 and Articles 94 and 95 thereof;

Having regard to Council Regulation No 11/65/EURATOM³ of 16 March 1965 laying down the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in the Netherlands, as last amended by Regulation (EURATOM) No 200/69,⁴ and in particular Article 13 thereof;

Having regard to the proposal from the Commission;

Whereas, in view of the changes in salaries made since 1 January 1969 for the staff of the *Reactor Centrum Nederland*, Regulation No 11/65/EUR-ATOM should be amended;

HAS ADOPTED THIS REGULATION:

Article 1

The following Article 3a shall be added to Regulation No 11/65/EURATOM:

'Article 3a

1. For the year 1969, members of establishment staff in employment on 1 September 1969 shall

receive a single cost-of-living allowance equal to 1% of the annual salary, the latter being calculated on the basis of the monthly salary as at 1 September 1969, including rent allowance and leave allowance.

That single allowance shall be not less than fl 110 and not more than fl 260. The minimum amount shall not apply to unmarried members of establishment staff aged less than twenty-one years on 1 September 1969 and not supporting a family.

A member of establishment staff whose employment ended before 31 December 1969 shall receive a single allowance calculated in proportion to the number of months of employment completed, any period of fifteen days or more being counted as a full month.

2. For the year 1969, members of establishment staff in employment on 1 September 1969 shall be granted a single allowance equal to 0.39% of the annual salary, the latter being calculated on the basis of the monthly salary as at 1 September 1969, including rent allowance for dependent children and leave allowance.

A member of establishment staff not having completed eight months of employment on 1 September 1969 or whose employment ended before 31 December 1969 shall receive a single allowance calculated in proportion to the number of completed months of employment, any parts of a month of fifteen days or more being counted as a full month.'

Article 2

The following Annex shall, with effect from 1 January 1970, be substituted for the Annex to Regulation No 11/65/Euratom:
