REGULATION (EEC) No 2613/70 OF THE COUNCIL  
of 15 December 1970

amending Annex I to Regulation (EEC) No 865/68 in respect of certain products falling  
within sub-heading No 20.07 A of the Common Customs Tariff

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the  
European Economic Community;

Having regard to Council Regulation (EEC) No  
865/68<sup>1</sup> of 28 June 1968 on the common organisation  
of the market in products processed from fruit and  
vegetables, as last amended by Regulation (EEC) No  
2275/70,<sup>2</sup> and in particular Article 2 (10) thereof;

Having regard to the proposal from the Commission;

Whereas Article 2 (1) of Regulation (EEC) No  
865/68 provides for an import levy to be charged on  
the various added sugars contained in the products  
listed in Annex I to that Regulation;

Whereas the charging of an import levy on certain  
products processed from fruit and vegetables falling  
within sub-heading No 20.07 A of the Common  
Customs Tariff which have a high concentration of  
natural sugar should be avoided; whereas that  
objective may be attained to a large extent by laying  
down, through an amendment to Annex I to  
Regulation (EEC) No 865/68, special provisions for  
applying the levy in question;

Whereas, pursuant to Article 9 (2) of Regulation  
(EEC) No 865/68, the tariff nomenclature provided  
for in this Regulation must be incorporated in the  
Common Customs Tariff;

HAS ADOPTED THIS REGULATION:

*Article 1*

The text of Annex A to this Regulation shall be  
substituted for that of Annex I to Regulation (EEC)  
No 865/68 in respect of the products falling within  
sub-heading No 20.07 A.

*Article 2*

The tariff nomenclature resulting from the provisions  
of Article 1 and set out in Annex B shall be  
incorporated in the Common Customs Tariff.

*Article 3*

This Regulation shall enter into force on 15 January  
1971.

This Regulation shall be binding in its entirety and directly applicable in all Member  
States.
