REGULATION (EEC) No 1610/71 OF THE COMMISSION

of 26 July 1971

amending Regulation No 470/67/EEC as regards the corrective amounts and the basic processing yield of certain qualities of rice

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 359/67/EEC¹ of 25 July 1967 on the common organisation of the market in rice, as last amended by Regulation (EEC) No 1553/71,² and in particular Article 5 (5) thereof;

Whereas experience in recent marketing years has shown that large quantities of certain qualities of rice are delivered for intervention, in particular at the beginning of the marketing year; whereas these deliveries are due *inter alia* to the level of the corrective amount which makes it profitable to bring them under intervention; whereas, in order to stimulate the search for market outlets, the corrective amounts for certain qualities should be altered in

such a way that they are brought under intervention only when no other outlet exists;

Whereas, in order to take account of the improved yield obtained within the Community from the processing of paddy rice of Arborio quality into milled rice, the yield in whole grains required for intervention should be increased from 55% to 56%;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Cereals;

HAS ADOPTED THIS REGULATION:

Article 1

The following shall be substituted for the Table appearing in Annex I to Regulation No 470/67/EEC:

Article 2

The basic processing yield in whole grains referred to in the second Table of Annex III to Regulation No 470/67/EEC shall be amended as follows:

- 63% for rice of the Balilla quality;
- 56% for rice of the Arborio quality;

Article 3

This Regulation shall enter into force on 1 September 1971.

This Regulation shall be binding in its entirety and directly applicable in all Member · States.
