REGULATION (EURATOM) No 2533/71 OF THE COUNCIL

of 22 November 1971

amending the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in Italy

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to Council Regulation No 259/68⁴ (EEC, Euratom, ECSC) of 29 February 1968 on the Staff Regulations of Officials of the European Communities and the Conditions of Employment of Other Servants of the Communities, and in particular the second paragraph of Article 4 and Articles 94 and 95 of the Conditions of Employment;

Having regard to Council Regulation No 9/63/Euratom² of 18 December 1963 laying down the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in Italy, as last amended by Regulation (Euratom) No 2049/70,³ and in particular Article 17 thereof;

Having regard to the proposal from the Commission;

Whereas in view of the changes in salaries made since 1 October 1970 and which will be made from 1 July 1972 in respect of employees in sectors covered by the 'Metalmeccanici' collective agreement, Regulation No 9/63/Euratom should be further amended;

HAS ADOPTED THIS REGULATION:

Article 1

With effect from 1 August 1971 the following salary scale shall be substituted for that appearing in the Annex to Regulation No 9/63/Euratom:
