## REGULATION (EEC) No 2849/71 OF THE COMMISSION

of 28 December 1971

supplementing Regulations (EEC) Nos 1373/70, 2637/70 and 432/71 as regards advance fixing certificates for the levy on beef and veal

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 805/68<sup>1</sup> of 27 June 1968 on the common organisation of the market in beef and veal, as last amended by Regulation (EEC) No 2727/71,<sup>2</sup> and in particular Article 12a (2) and Article 15 (3) thereof;

Whereas Commission Regulation (EEC) No 1373/70<sup>3</sup> of 10 July 1970, as amended by Regulation (EEC) No 2638/70,<sup>4</sup> laid down common detailed rules for the application of the system of import and export licences and advance fixing certificates for agricultural products subject to a single price system;

Whereas Commission Regulation (EEC) No 2637/70<sup>5</sup> of 23 December 1970 on special detailed rules for the application of the system of import and export licences and advance fixing certificates for agricultural products, as last amended by Regulation (EEC) No 2256/71,<sup>6</sup> laid down among other things the special detailed rules for the application of the system of import licences for beef and veal;

Whereas Commission Regulation (EEC) No 432/71<sup>7</sup> of 26 February 1971 laid down the information procedure to be followed for the application of the system of import licences for beef and veal;

Whereas Regulation (EEC) No 2838/71,<sup>8</sup> supplementing Council Regulation (EEC) No 805/68,

established arrangements for the advance fixing of the levy on certain beef and veal products originating in and coming from countries which, because of the length of the sea transport route, have concluded an agreement with the Community in this respect comprising certain guarantees;

Whereas Argentina has signed such an agreement with the Community; whereas the arrangements for the advance fixing of the levy established by the above-mentioned Regulation should be extended to that country;

Whereas application of such a system is subject to the entry into force of implementing provisions; whereas consequently Regulations (EEC) Nos 1373/70, 2637/70 and 432/71 should be supplemented;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Beef and Veal;

HAS ADOPTED THIS REGULATION:

*Article 1*

The following shall be substituted for the eighth indent of Article 1 of Regulation (EEC) No 1373/70:

— Articles 12a and 15 of Regulation (EEC) No 805/68.

*Article 2*

The following shall be substituted for the eighth indent of Article 1 of Regulation (EEC) No 2637/70:

— Articles 12a and 15 of Regulation (EEC) No 805/68.

*Article 3*

The following shall be substituted for the heading of Title VI of Regulation (EEC) No 2637/70:

'Beef and Veal: import licences, and advance fixing certificates.'

*Article 4*

The following shall be substituted for Article 38 of Regulation (EEC) No 2637/70:

1. The advance fixing certificate referred to in Article 12a of Regulation (EEC) No 805/68 shall be valid for thirty days from its date of issue within the meaning of Article 8 (1) of Regulation (EEC) No 1373/70.

2. The import licence referred to in Article 15 of Regulation (EEC) No 805/68 shall be valid for ninety days from its date of issue within the meaning of Article 8 (1) of Regulation (EEC) No 1373/70. However, the licence giving entitlement to the special import terms referred to in Article 14 (3) (b) (bb) of Regulation (EEC) No 805/68 shall be valid for ninety days from its actual date of issue.'

*Article 5*

The following shall be substituted for Article 39 of Regulation (EEC) No 2637/70:

1. The rate of the deposit relating to the advance fixing certificates referred to in Article 12a of Regulation (EEC) No 805/68 shall be 8 units of account per 100 kilogrammes net.

The rate of the deposit relating to the import licences referred to in Article 15 of Regulation (EEC) No 805/68 shall be 10 units of account per 100 kilogrammes net.'

*Article 6*

The following Article shall be added to Regulation (EEC) No 2637/70:

*'Article 39a*

Sections 13 and 14 of the application for an advance fixing certificate referred to in Article 12a of Regulation (EEC) No 805/68 and of the certificate shall include:

(a) one of the following endorsements:

"Argentine"

"Argentinien"

"Argentina"

"Argentinie"

(Argentina);

(b) an indication that the certificate makes it obligatory to import from the country in question.'

*Article 7*

The following shall be substituted for Article 40 of Regulation (EEC) No 2637/70:

'Treatment under the special import terms referred to in Article 14 (3) (b) (bb) of Regulation (EEC) No 805/68 shall be granted only on submission of the licence referred to in Article 15 of the latter Regulation, issued in accordance with the provisions of the following Articles.'

*Article 8*

The following shall be substituted for Article 1 of Regulation (EEC) No 432/71:

'Member States shall inform the Commission, not later than the second working day of each week, of the quantities for which the advance fixing certificates referred to in Article 12a of Regulation (EEC) No 805/68 were issued during the preceding week.'

*Article 9*

The following Article shall be added to Regulation (EEC) No 432/71:

*'Article 1a*

1. Member States shall inform the Commission twice monthly of the quantities for which the import licences referred to in Article 15 of Regulation (EEC) No 805/68 have been issued, stating the quantities for which the licences contain the entry specified in Article 41 (2) of Regulation (EEC) No 2637/70.

2. This information shall be given on the second working day following the fifteenth and last days of the month, respectively, for licences issued during the first and second halves of each month.'

*Article 10*

This Regulation shall enter into force on 1 January 1972.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
