

REGULATION (EEC) No 432/71 OF THE COMMISSION

of 26 February 1971

on information on the working of the system of import licences for beef and veal

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 805/68¹ of 27 June 1968 on the common organisation of the market in beef and veal, as last amended by Regulation (EEC) No 1253/70,² and in particular Article 25 thereof;

Whereas, in order to enable the Commission to have an overall view of the working of the system of import licences for beef and veal, Member States should provide the Commission with information thereon;

Whereas Commission Regulation (EEC) No 1373/70³ of 10 July 1970 on common detailed rules for the application of the system of import and export licences and advanced fixing certificates for agricultural products subject to a single price system, as last amended by Commission Regulations (EEC) No 2638/70⁴ and (EEC) No 2637/70⁵ of 23 December 1970 on special detailed rules for the application of the system of import and export licences and advanced fixing certificates for agricultural products, replaced Commission Regulation (EEC) No 1083/68⁶ of 26 July 1968 laying down detailed rules for the application of import licences for beef and veal, as last amended by Regulation (EEC) No 2239/69, with the exception of

Article 10 of the last-mentioned Regulation providing for certain information to be given on the working of the system of import licences;

Whereas the change to the system provided for by Regulation (EEC) No 1373/70 requires the detailed rules on such information to be amended;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Beef and Veal;

HAS ADOPTED THIS REGULATION:

Article 1

1. Member States shall inform the Commission twice monthly of the quantities for which licences have been issued, stating the quantities for which the licences contained the entry specified in Article 41 (2) of Regulation (EEC) No 2637/70.

2. Such information shall be given on the second working day following the fifteenth and the last days of the month, respectively, for licences issued during the first and second halves of each month.

Article 2

Regulation (EEC) No 1083/68 is hereby repealed.

Article 3

This Regulation shall enter into force on 1 March 1971.
